- 1. The candidate must be a citizen of India.
- 2. (a) Application form along with detailed terms and conditions can be downloaded from the Coffee Board's Website www.indiacoffee.org (Click on News).
  - (b) Application form can also be obtained from the Joint Director (Administration), Coffee Board, No.1, Dr. B.R. Ambedkar Veedhi, Bengaluru 560 001, on requisition during all working days (Monday to Friday), between 09.30 AM and 6.00 PM in person. Application form can also be obtained by post by sending a letter of requisition along with self-addressed envelope duly affixing requisite postal stamp.
- 3. The last date for submission of filled in application is 17.02.2020 (Monday).
- 4. The candidates should use only the prescribed Application Form obtained in person or by post or downloaded from the **Coffee Board's Website** <u>www.indiacoffee.org</u>. Application submitted by the candidate in any other format will summarily be rejected.
- 5. Before applying, candidates are advised to ensure that they fulfil the stipulated eligibility criteria for the post.
- 6. Recent passport size photograph should be firmly pasted at the place indicated in the Application Form and must be signed across the photograph, so that a part of the signature spreads over the application form beyond the photograph.
- 7. The application should be filled-in English (Capital Letters) only. Corrections, if any, should be legible and attested by the candidate. Candidates shall ensure that the particulars once submitted by them will be final and no further changes will be allowed thereafter.
