I. COMPANY PROFILE

Chennai Petroleum Corporation Limited (CPCL) was incorporated under the Indian Companies Act, 1956 with the objective of maximizing profit through manufacture and supply of petroleum products and other related business in a reliable, ethical and socially responsible manner and to be a world class energy company with a dominant presence in South India. CPCL is a subsidiary of Indian Oil Corporation Ltd. (IOC). CPCL is a Schedule 'B' Mini-Ratna CPSE in Petroleum sector under the administrative control of Ministry of Petroleum & Natural Gas.

Its Registered and Corporate offices are at Chennai, Tamil Nadu.

The shareholding of the Indian Oil Corporation in the Company is 51.89%.

The authorized and paid up capital of the Company was Rs. 1400 crores and Rs. 1149 crores respectively as on March 31, 2017.

II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Technical) is a member of the Board of Directors and reports to Chairman and Managing Director. - b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.
