For women candidates only: Women employees are eligible for 180 days of Maternity Leave, 730 days of Child Care Leave, 135 days of Child Adoption Leave, Special Allowances to women with disability, Posting of husband and wife at the same station, protection of women under provisions of CCS Conduct Rules 1964 and Age Relaxation for appointment upto 35 years (40 years for SC) for widows and divorced women.
- 7. The Commanding Officer of concerned units have the right to reject any application without assigning any reason. Similarly, HQ Southern Air Command has the right to change number of vacancies/reserved status at any time before selection.

debarred from any appointment in Railways; in addition, legal action may be taken against the candidate.

- 12.2. Any material suppression of facts or submitting of forged certificates/caste certificate by a candidate for securing eligibility and/or obtaining privileges. Including free travel for appearing in the examination shall lead to rejection of his/her candidature for the particular recruitment for which he/she has applied. Further, he/she will also be debarred from all examinations conducted by all RRB/RRC over the country for a period of 02 years and legal action may be initiated, if warranted,
- 12.3. A candidate will be debarred from examinations of all RRB/RRC for a specified period/lifetime if (i) the candidate submits multiple applications for the same post and category; (ii) the candidate submits multiple applications with different community for the same post & category; (iii) the candidate submits multiple applications with different photo (face) for same post & category and (iv) the candidate submits multiple applications with different documents for the same post & category
