GENERAL CONDITIONS

- 2. Application fee of Rs. 500/- [for Gen./OBC] and Rs. 250/- (for SC/ST/PWD) in the form of demand draft from any nationalized bank in favor of **Director**, **NIT Raipur** payable at Raipur must accompany the application. The DD should be drawn on or after the date of advertisement but before the last date prescribed for the receipt of the applications. Candidate shall write his/her Name, Post applied on the reverse side of the Demand Draft without fail.
- 3. Application fee once received by the Institute will not be returned back under any circumstances.
- 4. Candidates applying for more than one post are required to submit separate application form and fee. The applicant must ensure that he/she fulfills the eligibility conditions for the post on or before the closing date. Application submitted for a particular post is not transferable to any other post.
- 5. The applicant will be responsible for the authenticity of submitted information, other documents and photograph. Submission of any false and/or suppression / concealment of facts shall lead to rejection/cancellation of selection/recruitment.
- 6. The institute reserves the right to utilize the services of candidates who will be appointed for the post of Deputy Registrar in any department/section of the institute, at any point of time.
- 7. For the post of Registrar, the review of his/her performance upon completion of one year of service will be carried out by the committee constituted by the BOG.
- 8. The age limit and qualifications/experience etc. for all the posts shall be determined as on the last date of submission of applications forms. However, age relaxation will be considered in case of SC/ST/OBC (Non-Creamy Layer)/PWD and Ex-servicemen as applicable in Central Government.
- 9. Any application without required certificates/testimonials and without SC/ST/OBC (Non-Creamy Layer) certificate issued by the competent authority is liable to be rejected summarily.
- 10. Mere fulfillment of the required qualifications and experience, etc. does not entitle a candidate to be called for interview/selection.
