WALK IN INTERVIEW FOR FILLING UP THE VACANT POST OF SENIOR RESIDENTS AS PER DETAILS.

Only candidates who fulfil the eligibility criteria as per Residency scheme may appear before the interview panel as per schedule with their original documents along with the photo copy of the following documents :-

01. **Qualification :** MBBS with Post Graduate Degree (MD/MS/DNB, Diploma) in the concerned disciplines from a recognised university/ institution. Must not have completed 03 years Senior Residency in any recognized institution including regular and adhoc basis.
 02. **Pay Scale:** Pay Rs. 67700/- as per 7th CPC level 11 plus allowances as admissible under the rules.
 03. **Age limit:** 37 years for GEN, 5 years relaxable for SC/ST and 3 years for OBC candidates (belonging to Delhi only) on closing date of submission of application.
 04. **DMC Registration Certificate.**
- Tenure:** - The appointment will be initially for 89 days or till joining of regular Senior Resident which ever is earlier. That can be extended further upto a maximum period of 3 years subject to satisfactory performance, work and conduct report from concerned HOD.

Further, in case of non availability of candidates, as per the relevant scheme mentioned above, candidates may be considered in terms of the relaxation of provision as per circular No. F.121/26/2010/H&FW/1996-2045 dated 10.06.2011 of Deptt. of H&FW, GNCT of Delhi with the following relaxation :-

1. Upper age limit for eligibility for SR will be 40 years.
2. In case of non availability of fresh candidates, candidates who have completed 03 years of Residency as Senior Residents also be allowed to appear in the interview.
3. Separate merit list for candidates i.e. those who have completed 3 years of Sr. Residency and who are overage would be prepared.

4. Firstly, the list containing the names of fresh candidates would be exhausted for appointment and the second list would be used only after that.
5. All appointments for Residency from second list will be for 89 days only. It would not be renewable after 1 year subject to satisfactory performance, work and conduct report from concerned HOD.
6. Reservation of Person with Disability will be as per Government Rules.

Other conditions/requirements:-

1. The candidates who are already in govt. service should submit an NOC from his/her employer.
2. The service of Senior Residents shall be governed by residency schemes of Govt. of India/Civil Services (Temporary Rules.)
3. Candidates are required to bring all original certificates and testimonials along with two passport size photographs on the date of interview.
4. The posts will be filled up in phases as per availability of vacancies.
5. Appointment shall be subject to verification of certificates.
6. No TA/DA will be paid for appearing in the interview.
7. The appointment may be terminated at any time by 7 days notice given by either side i.e. the appointee or the appointing authority. No notice is required if service are terminated on disciplinary grounds.

If the vacant posts are not fillup than next interview be conduct on 13/02/2019.


