- 1) Reservation - For SC/ST/OBC/PH are as per Central Government rules. The candidates appointed under PWD(PH) quota will be adjusted against the vacancy or respective categories of SC/ST/OBC/General.
- 2) Tenure: - The tenure of Senior Residency is for a period of 03 years including any service rendered as SR earlier on ad-hoc/ regular basis in any institution. The appointment will be initially for a period of one year, which is extendable for a period of 03 years on an annual basis, subject to satisfactory work and conduct report from Head of Department and as per actual requirement.
- 3) Qualification & Experience required: PG Degree/Diploma in the concerned specialty from recognized university.
- 4) Age. Not exceeding 37 years as on 14/02/2020. Relaxation for SC, ST, OBC & PH are as per rules.
- 5) **Emoluments:** - As per Central Government rules adopted by ESIC.

- 1) Reservation - For SC/ST/OBC/PH are as per Central Government rules. The candidates appointed under PWD(PH) quota will be adjusted against the vacancy or respective categories of SC/ST/OBC/General.
- 2) Tenure: - The Tenure of the post will be for one year. However, in the case if the post is filled up on the regular basis the contract can be terminated even before the completion of the period of one year. The contract is also extendable beyond the period of 1 (one) year if the services of the candidate is found satisfactory and the vacancy and requirement continue to exists. The tenure can also be short closed after serving one months' notice. The medical Superintendent ESIC Hospital Baddi reserves the right to terminate or modify the contract at any time in case of alteration/modification in policy on the subject from the headquarter office or any other regulatory institution.
- 3) Qualification & Experience required: P.G. Degree or equivalent with post PG experience of 3 years or PG Diploma having post PG experience of 5 years respectively in the particular Specialty.

**How to apply:** - The eligible and willing candidates may submit their application form to the office of the Medical Superintendent ESIC Hospital Baddi for walk-in-interview along with duly filled in application form attached at annexure-A of this advertisement on date of interview. The candidate shall come along with original certificates and one set of self-attested photocopy of the relevant certificate/documents in support of Age, Qualification, Category, Experience, MCI/ State Registration and two recent passport size photographs at the time of interview

### **Terms & Conditions**

1. No TA/DA shall be paid for attending the interview and joining purpose.
2. In case of selection the candidate shall have to pay Rs. 10000/- (Rupees Ten Thousand) only as security Deposit through Demand Draft in favour of **ESIC Fund Account No. 1** payable at **Baddi** at the time of joining, which is refundable after successful completion of contract period and on production of "No dues certificate".
3. In case of selection the candidate shall have to enter into an agreement with the medical superintendent, ESIC Hospital, Baddi on a stamp paper (Non-Judicial Stamp Paper) of Rs. 100/- . The Stamp Paper will be borne by the candidate.
4. The competent authority reserves the right to fill up all or not to fill up any post without assigning any reason thereof.
5. Vacancies are likely to change depending upon actual requirement at the time of interview.
6. Candidate shall submit duly filled in Application Form (with self-attested photograph affixed on it) along with necessary self-attested copy of certificates towards educational qualification, experience. The candidate will also require to bring original certificates towards educational qualification & experience at the time of interview
7. Candidates working in Govt. Service should produce "No Objection Certificate" from their department at the time of interview.
8. The engagement will not confer any right of preference for regular appointment.
9. The engagement will be purely contractual and it will not confer any right to candidate for absorption in ESIC.
10. No claim for any service benefit like PF, Pension, Gratuity, Medical Allowance, Seniority, Promotion and leave will be admissible.
11. Hostel Accommodation Quarters will not be provided.
12. The decision of the Interview Board will be final on all aspects of selection and no further correspondence will be entertained under any circumstances.
13. The selection is subject to the candidates proving their medical fitness and verification of their character & antecedents.
14. Absence from work (duty) for a period of 15 (fifteen) days without proper permission of the competent authority will amount to voluntary abandonment of contractual-engagement and no further order of dis-engagement shall be necessary.
15. Any gross misconduct or negligence in the assigned duty may lead to termination of contract.
16. The part time specialist will not be entitled for any kind of leave.

17. The working hour for the part time specialist will be four days a week and four hour a day.
18. The principal of "No work no pay" will be applicable.
19. Candidate claiming reservation/age relaxation on ground of belonging to the OBC should submit the community certificate as prescribed by GOI. The OBC certificate should be latest and not prior to one year from the date of interview.
20. Candidates suffering from 40% or more of the relevant disability shall only be eligible for the reservation for PH category. Certificate of disability from any Govt. hospital should be submitted at the time of interview.
