Applications are invited from the eligible female candidates for the post of Accredited Social Health Activist (ASHA). A.

Period of receiving application: On all working days from 17.02.2020 to 11.03.2020 (from 11 am to 4 pm).

B. Selection Criteria:

Memo. No. HWF/NHRM-20/206/(Part-II)1631 Dated 27.06.2012 of Govt. West Bengal, Health & Family Welfare Department (NHRM)

C. Eligibility for being an ASHA:

- Should be married, divorced or widowed women,
- Should be a resident of the same service village for which she will be selected. Ration Card or EPIC or Certificate of Gr-A officer in this regard is mandatory to proof residential qualification.
- Should be within the age group of 30-40 yrs. In case of SC and ST candidates, the lower age limit is relaxed to 22 years. In both cases age of the applicant means her age as on 01.01.2020.
- Should be Madhyamik appeared or equivalent.
- 5. Women candidate who are Madhyamik pass or possessing higher qualification, only marks obtained in Madhyamik or equivalent examination will be considered.

D. **Mode of Application:**

- 1. Candidates should submit application in the format annexed as Annexure "A" to this notification on any working days (11:00 am to 4:00 pm) from 17.02.2020 to 11.03.2020 to the office of respective Block Development Officer BY HAND ONLY.
- 2. Application Form can be downloaded from the website: www.malda.nic.in
- 3. One candidate is allowed to submit only one application. More than one application, if submitted by the same candidate, remaining application(s) will not be entertained.

4. Candidate may collect information and assistance in filling of the Application Form from their respective Health Sub Centres / BPHC/RH.

E. <u>Documents to be submitted with the application (Photo copy with self attestation):</u>

1. Proof of residence as per para C 2.

2. Mark sheet of Madhyamik or equivalent examination as applicable, Mark sheet is to be provided by the candidates even in case of failure in the exam,

3. SC/ST Certificate, where applicable

- 4. Experience certificate, in case of Grade-I & Grade-II SHG members/trained dais/Link workers.
- Selection is based on marks obtained by the candidates in the Madhyamik/ equivalent examination (90% weightage)
- Score in the interview (10% weightage, including preferences as below). Interview questionnaire 8% and preference below 2%.
- Preference to be given to Grade-I & Grade-II SHG members/trained Dais/ Link Workers keeping the selection criteria fixed.

F. Whom to Apply:

1. The applicant may submit their application at the respective B.D.O. Office on or before the closing date & time by hand only. No application by post will be entertained.

G. General Conditions:

1. Candidates, before applying, should carefully read the instructions and ensure fulfillment of the eligible criteria at the time of submission of application.

2. Submission of application does not guarantee an appointment.

3. Candidates shall be disqualified at any time and at any stage during the selection process, in case of any misrepresentation of facts and documents. Appropriate legal action will be taken against such candidate.

4. Sadar Sub Divisional Level ASHA Selection Committee, Malda reserves the right to alter the modes of examinations or conduct, re-interview or cancel part or whole of any process of recruitment at any stage, if required.
