Online applications are invited from Arunachal Pradesh Scheduled Tribe (all the six posts are reserved for APST candidate) for filling up 6 (six) posts of Assistant Programmer Group- B (Non Gazetted), under the Office of The Chief Electoral Officer, Arunachal Pradesh, Itanagar in Level 6 Rs.35,400 - 1,12,400 under Pay Matrix of 7th Central Pay Commission plus other allowances as admissible to Arunachal Pradesh Govt. employees from time to time. The vacancy position is subject to variation.

(1) EDUCATIONAL QUALIFICATION:

Candidate applying for the post must possess Master's Degree in Computer Science/Master of Computer Applications /BE OR B.Tech in Computer Application OR Information Technology from a recognized University.

(2) AGE LIMIT:

The candidates must have attained 21 years of age and should not be more than 32 years as on 13.03.2020. However, the upper age limit is relaxable to 5 years for APST candidates and another 5 years relaxation to APST candidates of A P state govt. employees.

(3) METHOD OF SELECTION :-

The eligible candidate will have to appear in the written examination in the following subjects:-

A candidate who has secured a minimum of 33 % or more marks in each written examination papers and has secured 45% of marks out of aggregate total marks in the written examination papers shall be eligible for Interview/Viva-Voce. In other words selection for viva-voce test shall be based on the aggregate total marks secured in the written examination papers and subject to ratio of 1:3. The candidates securing less than 33% of marks in any of the written examination paper shall not be eligible for appearing in the viva-voce.

N.B The Commission will conduct recruitment test (Objective Type) before written examination, if it is deemed necessary to do so.

(4) HOW TO APPLY:-
