## ESSENTIAL QUALIFICATION

The applicant should possess a degree of Bachelor of Arts or Bachelor of Science or equivalent thereto from a recognized university and must have proficiency in operation of computers (word processing and spread sheets). The applicant should fulfill the condition of qualification on the last date of receipt of applications.

#### AGE LIMIT

The applicant should not be less than 18 years and more than 42 years of age as on 01.01.2020. Relaxation in age will be given to the candidates of reserved categories as per the Haryana Government instructions.

#### MODE OF SELECTION

The applicant shall have to pass a test at a speed of 80 W.P.M. in English Shorthand and 20 W.P.M. in transcription of the same on computer. He/she shall also have to qualify Computer Proficiency Test (Word Processing and Spread Sheets). Marks of Computer Proficiency Test would not be counted towards the final merit as it is qualifying in nature. Select list will be prepared on the basis of merit.

### DATE OF EXAMINATION

The applicants who fulfill the aforesaid qualification for the post of Stenographer Grade-III on adhoc basis will be required to appear for Shorthand Test/Computer Proficiency Test on the date and place to be intimated later-on official the website of this office i.e. https://districts.ecourts.gov.in/kaithal.
