Sub.: Limited Departmental Competitive Examination-2020 for appointment of departmental candidates to the grade of Sub-Inspectors of Police in CBI.

Sir,

A Limited Departmental Competitive Examination for appointment of departmental candidates to the grade of Sub-Inspector of Police in CBI in accordance with the provisions of the existing Recruitment Rules is proposed to be held on **03/05/2020 (Sunday)** at CBI Training Academy, Kamla Nehru Nagar, Hapur Road, Ghaziabad (U.P.) for filling 11 (UR-10, SC-01, ST-00) vacancies. However, the vacancy position available at the time of preparation of select panel will be taken into account.

Both Executive (irrespective of their cadre, i.e. G.D. or M.T. Constable to ASI) and Ministerial Staff (LDC to CA and Steno Grade-II) of CBI below the age 40 years (45 years for SC/ST candidates) as on 01.01.2020, with three years regular service in CBI since the date of joining in the Pay Band -1 and 2 up to the grade pay of Rs. 4200/- (pre-revised) and possessing the qualification i.e. Graduate in any discipline from a recognized University.

The scheme of the examination is enclosed herewith for ready reference.

Canteen employees/CBI, Scientific Staff/Drivers of CFSL, Data Entry Operators, Junior Hindi Translators & Deputationists personnel are not eligible to appear in the above Examination.

The question papers in General Knowledge and Law will be bilingual i.e. in English and Hindi.

The Branch/Zones/Units may please ensure that applications of only those candidates meet the prescribed physical measurements and other qualifications and experience should be forwarded to Head office for consideration. In case no employee from the Branch is eligible/ willing to appear in the examination, a **NIL** information may also please be sent. No application will be entertained after **16/04/2020**.

**Limited Departmental Competitive Examination for appointment of
Departmental candidates to the grade of Sub-Inspector of Police in CBI**

SCHEME OF EXAMINATION

1. Employees of the CBI both Executive (irrespective of their cadre i.e. G.D. Or. M.T. Constable to ASI) and Ministerial Staff (LDC to CA and Steno Grade-II) are eligible to appear in the Limited Departmental Competitive Examination for filling up 15% of vacancies through Limited Departmental Competitive Examination in the rank of Sub- Inspectors of Police, DSPE, CBI.

2. ELIGIBILITY:

Both-Executive and Ministerial Staff of CBI, possessing prescribed physical standard and below the age of 40 years and possessing the qualification i.e. Graduate in any discipline from a recognized university.

2.1 PHYSICAL STANDARD:

a) Height:

For men - 165 cms

For Women - 150 cms

Relaxable for:

i) Hills men and Tribals - 5 cms

ii) Below the age of 20 years – 2 cms

b) Chest:

76 cms with expansion

(There shall be no such requirement in case of female candidates), relaxable for a person under 20 years of age by 2 cms)

Vision:

Eye Sight (With or without glasses)

Distant Vision: 6/6 in one eye and
6/9 in the other eye.

Near Vision: 0.6 in one eye
0.8 in the other eye

2.2 Age Restriction

CBI employees (both Executive and Ministerial) upto 40 years (45 years for SC/ST candidates) as on 1st January 2020 are eligible to appear in the Limited Departmental Competitive Examination.

2.3 There is no reservation in the LDCE for OBC candidates. As per rules, there is reservation at 15% and 7.5% of vacancies for SC & ST respectively in promotion made on the basis of competitive examination limited to departmental candidates.

3. **Papers:**

The examination will consist of three parts i.e. :-

PART-I Written Examination 400 marks

PART-II Evaluation of Service Records 60 marks

3.1 The minimum percentage for qualifying written test is 40% in each subject with an aggregate of 45%. For SC/ST candidate, relaxation in minimum qualifying marks will be given as per instructions applicable on the date of issue of this Circular.

3.2 There will be no relaxation/ concession with regard to securing minimum 50% marks in evaluation of Service record. All candidates qualifying written examination of all categories are required to secure minimum of 50% marks in evaluation of service records.

3.3 The subjects for the written examination, the maximum marks and the time allowed for each subject will be as given below:-

PAPER-II	LAW	200	3 hours

3.4 The questions in Paper I will be aimed at testing the candidate's general awareness of the environments around him and its application to society. Questions will also be designed to test knowledge of current events and of such matters of every day observations and experience in their scientific aspect as may be expected of an educated person. The test will also include questions relating to India and its neighbouring countries especially pertaining to History, Culture, Geography, Economics, Science, General Politics and Scientific Research.

3.5 The questions on part B of Paper I will be descriptive type (and not of objective type), to test candidate's ability for orderly, effective and exact expression, combined with due economy of words. The questions will be designed to test the candidates understanding and knowledge of the language, its comprehension, vocabulary, spelling, grammar etc. There will also be questions on Precis Writing and Paragraph Writing.

3.6 A syllabus on paper II Law is enclosed.

3.7 The question papers in Paper-I will be of Higher Secondary Standard.

3.8 COMPOSITION OF SELECTION COMMITTEE

Selection Board for conducting LDCE shall be as under:

1. Joint Director - Chairman
2. DIG - Member
3. DIG - Member
4. S.P. - Member
5. S.P. - Member (Co-opted)

As per latest DOPT OM No. 35021/2/2009- Estt (C) dated 08.07.2009, No. 39016/7(S)/2006-Estt. (B) dated 04.06.2010 and latest OM No. 42011/2/2014-Estt.(Res) dated 13.02.2014 that wherever a Selection Committee Board exists or has to be constituted for making recruitment to 10 or more vacancies in Group 'C' or Group 'D' posts or service, it shall be mandatory to have one Member belonging to SC/ST/OBC and one member belonging to Minority Community in such Committees/Boards. Further, one of the members of the Selection committee/ boards, whether from the general category or from the minority community or from SC, ST OBC should be a lady, failing which a lady member should be co-opted on the Committee /Board.

In view of DOPT instructions, composition of Selection Committee i.e. Number of members may be increased subject to availability of one women and member belonging to SC/ST and minority community.

4. Part III Evaluation of Service Records:

Evaluation of service records will carry a maximum of 60 marks, The exact distribution of 60 marks for evaluation of service records will be notified before 30.4.2020. The evaluation of service records of the candidates qualifying in the written examination will be undertaken by the Selection Board as mentioned above.

Note: Director/ CBI will have the discretion to relax the minimum qualifying standard in any or all the papers of the written examination separately for General and SC/ST candidates.
