3. TENURE OF THE POST

The above said posts are purely temporary in nature and will be filled up on Contract basis, as a stopgap arrangement or till his/her services are required by the Chandigarh Administration. 4. UPPER AGE LIMIT AS ON 01.01.2020:

The upper age limit for the above said posts on contract basis are not exceeding 50 years.

5. EMOLUMENTS (On Contract Basis):

The emoluments to be paid on Contract Basis for the following posts are as under:-
