NOTIFICATION

Applications in the prescribed format are invited from the eligible candidates for the posts of Assistant Research Engineer (ASPE) and Research Associate (RA) on ELVEN Monthly basis in the All India Coordinated Research Project on 'Plasticulture Engineering and Technology' (AICRP-PET) operational in the University. These posts are on contractual basis but renewable based on the performance of the candidate. AICRP-PET is one of the permanent research scheme of Indian Council of Agricultural Research (ICAR) dedicated to use of plastic for agricultural production, post-harvest management, water resources etc. Presently, DBSKKV Dapoli center of AICRP-PET is working on soilless vegetable production, bamboo polyhouses, greenhouse automation, strength-analysis of greenhouse film locking system, development of multipurpose novel multi-crop hybrid dryer etc. To apply for these posts candidates are encouraged to send PDF copy of the application and the related material to the email id: aicrp.petdapoli@gmail.com such that it will reach before the last date i.e.04/08/2020 (Midnight). Please send the applications strictly in the prescribed format.

The applicants will be short listed on merit. If numbers of applications are more, only short-listed candidates will be called for the interview. The names of short listed candidates for the interview will be displayed on the University website i.e. **www.dbskkv.org.** In view of COVID-19 pandemic, depending upon the situation at the time of interview date, **the interview will be conducted by online or physically at university**. Also, send all certificates (education, experience, awards, special achievements etc.) and at least first page of conference / journal research articles. **Incomplete** / **not-signed applications will be rejected**. Email application + related material (in PDF format only) on **aicrp.petdapoli@gmail.com** before the last date **i.e. 04/08/2020 (Midnight).** Also, please submit separate application for the individual post. As far as possible include signed application and all related documents / certificates in a single PDF file and send by email or share with suitable cloud platform.

Other conditions:

- Age limit not more than 38 years (relaxation as per rule for SC/ST/OBC and other categories).
- 2. No TA/DA shall be paid to the candidates appearing for the interview.
- 3. The selected candidate will be required to give an undertaking on stamp paper worth Rs. 100/- that he/she will not leave the job during the appointment period and shall complete the 11 months assignment.
- 4. The candidate will be initially appointed purely on contractual basis for 11months period or up to the termination of the project whichever is less. Also, the candidate will be considered for reappointment in the project based on the candidate's performance & availability of funds.
- The candidate will have no claim for appointment on the regular establishment in the service of Dr. Balasaheb Sawant Konkan Krishi Vidyapeeth, Dapoli on the basis of these eleven monthly contractual appointments.
- 6. The candidate will have to give one-month advance notice if he/she desire to leave the job failing which he/she will have to surrender one-month salary in lieu of the notice period. However, his/her resignation will only be accepted to join other permanent jobs (i.e. only University / ICAR / Government jobs). In normal course, he/she has to complete eleven months contract or deposit all eleven months salary in university account in case the candidate wanted to resign the job at any cost. The candidates will not be allowed to join higher degree course / higher education during this 11 monthly contractual period.
- 7. The Principal Investigator (PI) of the center reserves the right to terminate services of the candidate who is not performing up to the mark or without giving any reason and the decision of the Principal Investigator (PI) will be final in this matter.
- 8. The University reserves the right to reject one or all the applications without any reason thereof.
- 9. As these schemes are research-oriented, the selected candidate would render his/her services with due responsibility and give the result of the scheme as well as other information as per the requirement of a scheme to concerned agency/office and as per the directives from the PI / University.
- 10. The selected candidate has to submit NOC from the previous employee before joining his/ her post if he/ she is already employed elsewhere.
- 11. Canvassing in any form render the candidate disqualified for the post.
