Tech (and equivalent) with valid GATE score in ECE/EE/Telecom or equivalent degree/ discipline. <u>For PA:</u> Full time B. Tech./BE with first class in in ECE/EE/Telecom or equivalent degree/ discipline. Note: Those who are in the final semester of M. Tech or B. Tech can also apply. In the event of selection to either JRF or PA position, joining will be subjected to submission of the respective provisional degree certificate.
4.	Desirable	1. Strong background in signal processing and communications. 2. Ability to code in MATLAB or C
5.	Consolidated Emoluments	Rs. 31,000 + HRA (for JRF) Rs. 23,000 consolidated (for Project Associate)
6.	Duration of the project	Maximum 2 years

1	Selected candidates shall not have claim on any regular position and shall not be bestowed any of the privileges like Housing, Medical Facility and Other benefits available to the regular employees of the Institute.
2	Applicants are advised to ensure, before appearing for online selection process, that they possess the minimum essential qualification and experience laid down for the post. Qualification obtained has to be from recognized University/Institute. Eligibility in terms of age, qualification and experience of a candidate shall be considered as on the date of Selection Process.
3	The number of vacancies indicated in the notification is tentative. IIT Dharwad reserves the right to increase or decrease the number of advertised posts at the time of selection. Further, IIT Dharwad reserves the right to NOT fill any of the posts advertised.
4	The selection process is online, and hence TA/DA will not be applicable.
5	In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after issue of the appointment letter, the Institute reserves the right to <i>modify, withdraw</i> or <i>cancel</i> any communication made to the Applicants.
