Walk - in-Interview

A walk-in-interview will be held on 20.07.2020 at 02:00 PM (Monday) for appointment of two posts of Senior Resident (Dental) on emergent basis (01 Post of Public Health Dentistry and 01 Post of Conservative Dentistry), for initial period of 44 days, purely on ad-hoc basis or till regular incumbent joins, whichever is earlier.

The posts are reserved for OBC category. In case of non-availability of Reserve Candidate, seat will be considered as **open for all categories**.

No hard copy will be entertained in this regard. Candidates will also have to produce all original documents at the time of interview. > Eligibility:

- 1. Passed MDS in the concerned specialty (not before 19.07.2015 i.e. within 5 years), from a recognized University.
- 2. The candidates should be registered with State Dental Council with MDS degree.
- 3. OBC candidates are required to submit their Caste Certificate issued by Competent Authority of Govt. of N.C.T. of Delhi.
- ➤ **Emoluments**: Pay Matrix of Level-11 (Rs. 67,700 2,08,700/-) + Usual allowances as admissible under the Rules.
- > Maximum Age Limit: 37 years as on 20.07.2020.

> Recruitment Conditions:-

- 2. Other service conditions as prescribed from time to time by the Hospital will be applicable.
- 3. The service will be governed as per residency scheme.
