EXPERIENCE:

- i. **For the candidates possessing MD/MS degree from MCI recognized medical college:**
 - a) **Three years teaching experience** in the subject as Resident/ Registrar/ Demonstrator/Tutor in a recognized medical college either during the post graduation course or after obtaining postgraduate degree in the subject.
 - b) **One year as Senior Resident** in the concerned subject in a recognized/Permitted medical college.
 - c) Provided that in disciplines where the post of Senior Resident is not prescribed in the applicable Minimum Standard Requirements for the Medical College for 100 Admissions Annually Regulations one year experience as Tutor/Demonstrator/Resident/registrar after obtaining Post Graduate Degree in the concerned discipline shall be required .
- ii. **Equivalence of qualification of DNB (broad specialties) with MD/MS:**
 - a) Those candidates who have undergone DNB training in an institution which now run MCI recognized postgraduate degree courses in a given subject, their DNB qualifications shall be considered at par with MCI recognized qualifications that subject only.
 - b) **One year as Senior Resident** in the concerned subject in a recognized/Permitted medical college.
 - c) Provided that in disciplines where the post of Senior Resident is not prescribed in the applicable Minimum Standard Requirements for the Medical College for 100 Admissions Annually Regulations one year experience as Tutor/Demonstrator/Resident/registrar after obtaining Post Graduate Degree in the concerned discipline shall be required.
- iii. **Additional training of one year for equivalence of qualification of DNB (broad Specialties) with MD/MS:**
 - a) Those candidates who have undergone DNB training in broad specialties in hospital/ institution other than mentioned in (ii) above, shall undergo **one additional year of senior residency or equivalent training or research job** in a MCI recognized hospital/ institution, provided such qualifications are notified in the Postgraduate Medical Education Regulations 2000”.
 - b) **One year as Senior Resident** in the concerned subject in a recognized/Permitted medical college.
 - c) Provided that in disciplines where the post of Senior Resident is not prescribed in the applicable Minimum Standard Requirements for the Medical College for 100 Admissions Annually Regulations one year experience as Tutor/Demonstrator/Resident/registrar after obtaining Post Graduate Degree in the concerned discipline shall be required.

B. PAY & ALLOWANCES:

4. Retired candidates from Central/ State Govt. / PSU from the equivalent posts are eligible to apply. Persons working in recognized/ approved Private Medical Institutions fulfilling eligibility criteria for the post may also apply.

The candidates have to attach the self-attested copies of all the relevant certificates/ testimonials on support of date of birth (Secondary exam certificate/Admit Card), category, sub-category i.e. educational qualification, teaching experience, Pension Payment Order (PPO), etc. with the application form and have to **produce originals thereof at the time of Walk in Interview.**

C. TERMS OF CONTRACT:

The engagement will be for a period till the joining of regular incumbent. The contract would initially for one year, to be extendable for another one year on satisfactory performance, with a minimum term of one year in respect of teaching faculty or attaining the age of 70 years whichever is earlier.

Research Publications in Indexed Journals, (vii) Pension Payment Order (PPO), in case of retired employees from Govt. organizations (Viii) NOC for in service candidate from employer (ix) Service bond release certificate if applicable along with **original documents**.
