Applications are invited for filling up the post of Deputy Director General (Admin.) in the pay scale at Level-15 of Pay Matrix of 7th CPC on deputation basis in Indian Council of Forestry Research and Education (ICFRE), Dehra Dun in pay scale indicated against the post with allowances as admissible under rules in ICFRE:-

The eligibility criteria and other terms and conditions for the above said posts are stated below:-

(1) Dy. Director General (Admin.), ICFRE, Dehra Dun

A. For Members of Indian Forest Service

A.1 Essential Qualifications:

A serving member of Indian Forest Service having completed 26 years of service with reference to year of allotment

B. For Scientists:

B.1 Essential Qualifications:

A candidate having First Class Master Degree in Basic Sciences/Agriculture/Forestry/Management/Social Sciences from a recognized University with 26 years of service with reference to the date of appointment as Group 'A' Scientist, and who has 15 years experience in Forestry Research/Extension or Educations.

C. Desirable Qualifications: For both members of Indian Forest Service and Scientists

1. Working experience of Personnel/Administrative/Financial matters at senior level in the Government or similar Research/Educational organization.
2. Experience in preparation of budget and its control, maintenance of organizational accounts.
3. Conversant with all Government Rules and Regulations regarding financial and administrative matters of the Government/Autonomous bodies including audit of Accounts.

Head Quarters:- The Head quarter of the Deputy Director General (Administration), ICFRE shall be Dehra Dun. The Director General, ICFRE, with the approval of the MoEF&CC can transfer the incumbent from one post to other, as and when circumstances, so warrant. However, the officer appointed would be liable to serve anywhere in India.

Age:-Not exceeding 57 years as on 31.10.2020.

Eligibility:-The crucial date for determining eligibility criteria shall be 31.10.2020.


Tenure:- The tenure of deputation shall ordinarily be five years or till superannuation, whichever is earlier, and as per guidelines of the Government of India.

“Cooling off” requirement:- “Cooling off”, period for the posts shall be as per guidelines of the Government of India.

Debarment:- In case an officer, to whom offer of appointment to any of the above posts does not report either on his own volition or at the instance of the Cadre authority, he would be debarred from consideration for a post in ICFRE for a period of 5 years.

General Instructions:

1. Applications with complete bio-data together with a fee of Rs.500/- (Rupees Five hundred only) in the form of Demand Draft drawn in favour of **Accounts Officer, ICFRE** payable at Dehra Dun should reach the office of the Secretary, Indian Council of Forestry Research and Education, P.O. New Forest, Dehradun on or before 31.10.2020.
2. Application and the envelope should be superscripted as “Application for the post of _____” against Advt.No.1/DDG(Admin.)/2020-ICFRE”. Applications incomplete in any respect shall be summarily rejected.
3. In no case the Council will be responsible for non-receipt of applications or any delay in receipt thereof on any account whatsoever. No application received after the stipulated last date will be entertained under any circumstances and all the late applications will be summarily rejected.
4. The candidate must submit their application through proper channel. The concerned department/organization should enclose vigilance clearance report and Annual Confidential Reports of the officer for the last seven years for the years **2012-2013 to 2018-2019** while forwarding the applications of the candidates. However, an advance copy can be submitted by the candidate along with the prescribed fee to the council.
5. The IFS officers who have not completed the mandatory “Cooling off” period in his/her parent cadre between two spells of deputation as on **31.10.2020** will not be considered for the post.
6. The candidate, who applies against this advertisement, in case of his non-selection to the post may be considered for the posts of similar level under Council falling vacant within a year of the last date of this advertisement, subject to the condition of their written consent.
7. The Council reserves the right to relax, the qualifications/experience in case of exceptionally qualified and meritorious candidates.
8. The Council reserves the right not to fill up the vacancy advertised, if the circumstances so warrant in the interest of the Council.
9. Person who has applied against earlier advertisement dated 14.08.2020 for the post of Dy. Director General (Admin.), ICFRE need not apply again. His eligibility criteria shall be determined as per the terms and conditions of this advertisement.
