  All Correspondence with candidates shall be done through email only. Responsibility of downloading and printing of letter shall be that of the candidates. NMRL will not be responsible for any loss of e-mail sent due to invalid/wrong e-mail ID provided by the candidate or delivery email to SPAM/BULK mail folder etc. Selection Procedure :-
- No Interview will be held due to ongoing pandemic. Board constituted by the Director, NMRL for the purpose will go through the applications, and shortlist the candidates (as per the vacancies indicated above).
- Candidates will be selected strictly on the merit basis (percentage/marks of essential qualification). Only selected candidates will be informed through offer

## Terms & Conditions for selection of Apprentices :-

- Candidates must have registered their names at www.mhrdnats.gov.in & non-registered candidates are-likely to be rejected.
- The fresh pass-out candidates (passing their respective courses in 2017, 2018, 2019) only can apply: Candidates who have passed the qualifying examination earlier than 2017 are not eligible. Candidates with post-graduation
- are not eligible to apply.

  Those candidates who have completed the qualifying examination as regular candidates are only eligible to apply.

- Coast Guard cannot guarantee the safe keeping of any electronic devices. Candidate will not be allowed to go to toilet or leave examination venue / hall for any reasons after the commencement of the written examination. All candidates will be frisked prior entering examination venue.
- (u) All candidates are requested to be watchful and immediately bring to notice of invigilator for any suspicious action by any of the candidates. Indian Coast Guard reserves the right to cancel the entire recruitment at any
- stage of the recruitment process without assigning any reason.
- Travel Expenses, SC/ST candidates, who are not employed by the Central /

- Graduate degree holders who had training or job experience for a period of one year or more after attaining the essential qualification shall NOT eligible for being engaged as an apprentice under the act.
- The period of training will be 12 months commencing from execution of the contract of Apprenticeship.
- Reservation will be applied as per the provisions of the Apprentices Act. 1961 and Apprenticeship Rules 1992 as amended from time to time. Applications belonging to SC (Scheduled Caste)/ST (Scheduled Tribe)/OBC (Other Backward Classes)-Non Creamy Layer shall produce their caste certificates in prescribed format issued by the competent authority.

  The selected candidates must execute a contract for a period of one year of training as per provision of the Apprentices Act, 1961 and rules framed there under. Before applying, the candidates should ensure that he/she fulfills the eligibility
