Pension Fund Regulatory and Development Authority (PFRDA/ **Authority)** is a statutory regulatory body established under the PFRDA Act (23 of MONTHLY 2013) passed by the Parliament of India with the mandate to promote, develop and regulate Pension sector in India. PFRDA invites applications from Indian citizens for engagement of One (01) 'Junior Economist' purely on contract basis. The number of positions is liable to change.

Post Graduation in Economics/ Econometrics/ Developmental Economics from a University recognized by UGC or an Institute established by an Act of Parliament of India.

Not more than 35 years.

EXPERIENCE: (As on 31/10/2020)

Minimum of one (01) year post qualification experience in the field of

economics, preferably in the financial sector.

TENURE OF CONTRACT:

The selected candidate would be engaged purely on *contract basis* for a period of three (03) years. The year-on-year continuity of contract shall be subject to satisfactory annual review of candidate's performance. The tenure of contract may be further extended after its expiry depending on requirement and mutual consent of both the parties.



The contract may be terminated by either of the parties without assigning any reason, by giving two (2) months' notice or payment of two (2) months' remuneration in lieu thereof to the other party.

The selected candidate is *inter-alia* expected to assist in performing Market Watch & Research related tasks like analysis of NPS/ APY data, upkeep of database on NPS/ APY; Preparation of Annual Report of PFRDA; Monthly Pension Bulletins; Co-ordination with FSDC/ FSLRC/ IOPS/ OECD and Interregulatory forums etc.
