- **Qualification:** MBBS with post graduate Degree/Diploma/DNB in the concerned specialty. In case of non availability of eligible candidates, Non PG candidates having three years experience in medicine or two years in medicine and one year in specialty concerned or three years in specialty concerned may be considered. Candidate should have a valid registration with Delhi Medical Council and the candidate must not have completed 03 years of Senior Residency including Regular & Ad-hoc period.
- 3. Emoluments: As per 7th CPC Pay Matrix Level 11, Pay Rs. 67700 plus admissible allowances as per rules per month.
- 4. Age Limit:- (As on closing date), 45 years for General/EWS category as per order no. F.No.DHF&W/Q015/57/2016-HR-Medical-Secy(H&FW)#11245062/1502-08, dated 26/11/2020., Relaxable for SC/ST by 05 years and for OBC (Delhi only) by 03 years. Only OBC candidates of Delhi will be eligible and are required to submit their caste certificate issued by the Competent Authority of GNCT of Delhi. The certificate should mention their belonging to non-creamy layer. Tenure:- Senior Residents who have completed three year of Senior Residency (including those who are working on Adhoc basis in JSSHS) shall also be allowed to appear in the Interview and will be offered residency only if fresh candidates for the post of Senior Residents are not available. There would be no extension for any Senior Resident beyond one year of appointment under relaxed provisions (vide Circular No. 121/26/2010/H&FW/1996-2045 dated 10/06/2011. In any case, no candidate shall be eligible, who has already completed four years of residency under the Residency Scheme.

 Those who have completed three years of regular SR ship will be offered SR ship on Ad-hoc basis (89 days) for maximum period of one year.
