Scale of Pay & conditions of Service-The appointment to this post will be initially on contractual basis carrying a remuneration of Rs. 16880/- per month(for 1st year) as per Govt. in G.A. & P.G. Department Notification No. 19569/G.A. dated 12.09.2017 and Condition of Service will be guided by (Contractual Appointment) Rules, 2013 & Food Safety Standard Rules-2011.

ELIGIBILITY

- i) Age:-Must not be below 21 years and above 32 years of age as on 1.1.2020 with usual age relaxation as per rules for SC,ST,SEBC,Women,PwD,Ex-servicemen & In-service contractual employees.
- iii) Minimum Educational Qualification:- The candidate applying for the post must have passed
- (a) Degree in Food Technology / Dairy Technology / Biotechnology / Oil Technology / Agricultural Science / Veterinary Science / Bio-Chemistry / Microbiology / Masters Degree in Chemistry / Degree in Medicine from AICTE approved institution or recognized University securing minimum 60% marks.
- (b) Besides the candidate to possess adequate knowledge in computer application i.e windows, MS office (Word, Excel & power point), MS Access & Usage of Internet services.

PLAN OF EXAMINATION:

Stage-I-Main Written Examination- 200 marks-Two papers (Objective type to be conducted in CBRE mode/OMR sheet)

Paper-I-Composite Paper (General Studies, Mathematics, Computer Application & English)-100 marks,

Paper-II-Technical Paper(Food Safety Act & Rule-50 marks & Chemistry-50 marks)-100 marks, (0.25 negative mark per each wrong answer for paper-II only).

Candidates three times of vacancies in order of merit category wise basing on the marks secured in Written Examination shall be shortlisted for Computer Skill Test.

Stage-II-Computer Skill Test (CST)-50 marks-qualifying only (Qualifying mark-15),

Stage-III-Certificate Verification- Candidates qualifying in the Computer Skill Test Shall be called for Verification of Original certificates/documents.

Select List-The Select List shall be prepared in order of merit categorywise basing on the marks secured in the Main Written Exam. who qualifies in CST &found eligible after verification of original documents.

EXAMINATION FEES: The candidates other than SC,ST & PwD shall have to pay non-refundable examination fee of Rs.200/- (Rupees two hundred) only through online mode as per details to be mentioned in the detailed advertisement.
