Note 1: Above vacancies may increase or decrease depending upon the actual requirement.

Note 2: The Govt. of India, Ministry of Personnel, PG & Pension, DoPT vide O.M. dated 15.01.2018 has revised the quantum of reservation for Persons with Benchmark Disabilities to 4% along with introduction of some new categories of disabled.

The new categories of disabled introduced vide DoPT above referred OM dated 15.01.2018 are not included in the existing identification of posts reserved for PWDs for the above mentioned posts.

SCALE OF PAY: Level - 11 of Pay Matrix with initial pay of Rs. 67,700/- as per 7th CPC.

In addition to Pay, DA, NPA, HRA and Transport Allowance will be also be admissible as per rules in force from time to time.

AGE LIMIT: Not exceeding 45 years as on **01.02.2021**. Relaxable up to 5 years for employees of the Employees' State Insurance Corporation and Government Servants. Upper age limit is also relaxable for SC/ST/OBC/PWD/Ex-Servicemen candidates as per Govt. of India instructions.

Relaxation in age - SC / ST / OBC candidates will be eligible for age relaxation to the extent of the posts reserved for these categories. In case vacancies are not reserved for these categories of applicants in any of the above specialities, the candidates shall not be eligible for any age relaxation.
