I. COMPANY PROFILE

Mumbai Railway Vikas Corporation Limited (MRVC) was set up with the objective to augment transport capacity to meet the continual growth in the number of commuters in Mumbai, through developing coordinated plans, and implementing rail infrastructure project, integrating urban development plan of Mumbai with rail capacity (and investments), undertaking commercial development of Railway land and air space. The role of MRVC is important in coordinating with the obtaining assistance of concerned bodies to provide infrastructural support for economical, efficient and sustainable suburban transport system of Mumbai. It is a Schedule - 'A' CPSE with the administrative jurisdiction of Ministry of Railways.

Its registered and Corporate Offices are at Mumbai, Maharashtra.

The company employed 256 regular employees (Executives: 87, Non-Executives: 169) as on 31.3.2020.

The authorized and paid up capital of the Company was Rs.25 Crores and Rs. 25 Crores respectively as on 31.03.2020.

The shareholding of the Government of India and Government of Maharashtra in the company are 51% and 49% respectively as on 31.03 2020.

II. JOB DESCRIPTION AND RESPONSIBILITIES

The Chairman & Managing Director is the Chief Executive of the Company and accountable to its

Board of Directors and Government/ Shareholders. He/She is responsible for the efficient functioning of the company for achieving its corporate objectives and performance parameters.

III. ELIGIBILITY
