Pradesh dated 25th June, 2019 for inviting objections and suggestions from the general public, vide madepartment notification of even number dated 14th June, 2019 as required under section 186 of the Himachal Pradesh Panchayati Raj Act, 1994 (Act No. 4 of 1994):

Now, therefore, in exercise of the powers conferred by section 186 of the Harmachar Pradesh Panchayati Raj Act, 1994 (Act No. 4 of 1994), the Governor of Himachar Pradesh is pleased to make the following rules, namely:-

Short title

 These rules may be called the Himachal Pradesh Panchayati Raj (Appointment and Conditions of Service of Panchayat Secretary in Zila Parishada (Rafea, 2019.

Definitions.

- 2. (1) In these rules, unless the context otherwise requires,--
 - (a) "Act" means the Himachal Pradesh Panchayati Raj Act, 1994; and
 - (b) "Director" means the Director of Panchayati Raj, Himachai Prades"
 - (c) "Form" means a Form appended to these Rules.
 - (2) The words and expressions used but not defined in these Rules shall have the same meaning as respectively assigned to them in the Act.

Number of Posts.

3. There shall be such number of posts of Panchayat Secretary as sanctioned in it may be sanctioned by the State Government from time to time in the respective Zila Parishads.

Scale of Pay

4. The scale of pay for the post of Panchayat Secretary shall be as under-

(a) Pay band for regular appointees. PB-RS.5910-20200 + 1900 Grade Pay, and after two years 10300-34800+3200 grade pay.

(b) Emoluments for contractual appointees: 5910+1900 GP 7810 - per month

6. A person to be appointed as Panchayat Secretary shall be eligible if he is having the age between 18 and 45 years.

Provided that the upper age limit for direct recruits will not be applicable to the candidates already in service of the Government including those who have been appointed on ad-hoc or on contract basis:

Provided further that if a candidate appointed on ad-hoc basis had become overage on the date when he was appointed as such he shall not be eligible for any relaxation in the prescribed age limit by virtue of his such ad-hoc or contract appointment;

Provided further that upper age limit is relaxable for Scheduled Castes/Scheduled Tribes/ Other Categories of persons to the extent permissible under the General or Special Order (s) of the State Government

11. The candidate to be appointed as Panchayat Secretary should be bonafide resident of Himachal Pradesh

In case of recruitment by lateral entry (ies) 12. 20% Tailoring Teacher appointed in Gram Panchayats having 10 years service, passed minimum 10+2 examination from a recognized Board approved by the Himachal Pradesh Government and should have knowledge of word processing and working on various software being implemented at GP level. Due to dying cadre of Tailoring Teacher their recruitment will be done on the basis of minimum required qualification and then 20% quota reserved for them will be given to direct recruitment on regular basis or on contract basis, as the case may be.

Selection for appointment.

13. The selection to the post in case of direct or contractual appointment, as the case may be, shall be made on the basis of criteria fixed by Government from time to time or Himachal Pradesh Staff Selection Commission Hamirput or other recruiting Authority, as the case may be, so consider necessary or expedient by a written test or practical test, the standard/syllabus etc. of which, will be determined by the Commission/other recruiting authority or by the State Government, as the case may be.

National Pension Scheme 14. The regular Panchayat Secretary under the Zila Parishad Cadre shall be counted for availing the facility of National Pension Scheme (NPS) as may be notified by the State Covernment.

15. The other conditions of service in the case of regular appointees shall apply mutatis-mutandis as are applicable in the case of State Government employed equivalent to the category.

Selection for appointment to the post by Contract Appointment. 16. Notwithstanding anything contained in these rules, contract appointment in the post will be made subject to the Terms and Conditions given below:

(I) CONCEPT:

(a) Under this policy, the Panchayat Secretary in Zila Parishad, will be engaged on contract basis initially for one year, which may be extendable on year to year basis.

Provided that for extension/renewal of contract period on year to year barrathe Chief Executive Officer Panchayat Samiti shall issue a certificate that the service and conduct of the contract appointee is satisfactory during the year and only then his period of contract is to be renewed extended by appointing authority

(II) POST SHALL BE IN THE PURVIEW OF HPSSC, HAMIRPUR AND OTHER RECRUITING AGENCY TO BE DECIDED BY THE GOVERNMENT.

The Secretary Zila Parishad after obtaining the approval of the Government to fill up the vacant posts on contract basis shall send requisition to the Himachal Pradesh Staff Selection Commission Hamirpur or any other recruiting agency, as the case may be, to be decided by the Govt, for appointment/ selection.

(c) The selection shall be made in accordance with the eligibility conditions specified in these rules.

(III) CONTRACTUAL EMOLUMENTS:

The Panchayat Secretary appointed on contract basis will be paid consolidated fixed contractual amount 47810 P.M. (which shall be equal to minimum of the pay band+ Grade pay). 3% of the minimum of pay band+ grade pay of the post as annual increase in contractual emoluments for the subsequent years(s) will be allowed if contract is extended beyond one year.

(IV) APPOINTING/DISCIPLINARY AUTHORITY:

The Chief Executive Officer of the concerned Zila Parishad will be the appointing and disciplinary authority but for day to day control it with respect to attendance, tour programme, sanction of leave up to 15 days, work and conduct or respect of contractual and Reviewing Authority of ACR in respect of regular Panchayat Secretary of Zila Parishad Cadre, shall be Chief Executive Officer Panchayat Samiti and the Panchayat Secretary shall also work under the overall supervision of Chief Executive Officers of Panchayat Samiti Secretary ZP shall of head of office for Panchayat Secretary.

(V) SELECTION PROCESS:

Selection for appointment to the post in the case of Contract Appointment will be made by the Himachal Pradesh Staff Selection Commission. (VI) APPOINTMENT AND AGREEMENT:

(VII) TERMS AND CONDITIONS:

- (a) The contractual appointee will be paid fixed contractual amount a Rs. 7810/- P.M. (which shall be equal to minimum of the pay band grade pay). The contractual appointee will be entitled for increase in contractual amount i.e. 3% of minimum of the pay band grade pay of the post to further extended year(s) and no other allied benefits such as senior /selection scales etc. will be given.
- (b) The service of the Contract Appointee will be purely on temporary basis.

 The appointment is liable to be terminated in case the performance conduct of the contract appointee is not found satisfactory.
- (c) Contract Appointee will be entitled for one day causal leave after puttone one month service. This leave can be accumulated up to one your. So, leave of any other kind is admissible to the contract appointee. He She shall not be entitled for Medial Re-imbursement and 1.10 etc. only maternity leave will be given as per rules.
- (d) Unauthorized absence from the duty without the approval or the consense Executive Officer Panchayat Samiti or appointing authority as the consense may be, shall automatically lead to the termination of the contract Contract Appointee shall not be entitled for contractual amount for the period of absence from duty
- (e) An official appointed on contract basis who has completed times extenure at one place of positing will be eligible for transfer on need base within the respective Zila Parishad on administrative ground.

- Selected candidate will have to submit a certificate of his her time. The season a Ciovernment/Registered Medical Practitioner Woman candidate pregnant beyond 12 weeks will stand temporarily unfit till to confinement is over The woman candidate will be re examined for a fitness from an authorized Medical Officer Practitioner
- (g) Contract appointee will be entitled to IA/DA it required to go on four in connection with his her official duties at the same rate as applied the regular counter-part official at the minimum of pay scale
- (h) Provisions of service rules like FR/SR Leave Rules. GPI Rules. Pension Rules and Conduct rules etc. as are applicable in case of regular employees will not be applicable in case of contract appointees. They will be entitled for emoluments etc. as detailed in this Column.

Appointing Authority and allocation of Paneliavats.

17. The Chief Executive Officer of concerned Zila Prishad shall be the appointing authority and letter of appointment shall be issued by the Chief Executive Officer Zila Parishad, who shall depute the Panchavat Secretary in a Panchavat Samue within the district and also allocate the Gram Panchavats to a Panchavat Secretary.

Seniority of Panchayat Secretary

18. The seniority of the regular Panchayat Secretary shall be determined from the date of joining prepared at district level and consolidated and maintained at Directorate level for the Panchayat Secretary who had initially been appointed as Panchayat Sahayak. Director may traine other rational guidelines for determining the seniority. However, the seniority of candidates appointed through Board Commission shall be maintained on the basis of merit, so devised by the Board Commission.

Reservation.

19. The appointment to the service shall be subject to orders regarding reservation in the service for Scheduled Castes. Scheduled Tribes/ Backward Classes. Other Categories of persons issued by the Himachal Pradesh Covernment from target time.

Job Chart.

20. The job chart for the Panchayat Secretary shall be such as may be specified by the Director from time to time.

Training and Examination.

21 The members of the service shall have to qualify examination or to appears

such courses for training to be specified by the Director, from time to time

Provided that three chances shall be provided to qualify such examination, within five years and in the event of not qualifying the examination by the concerned employee, the increment of such employee shall be hable to be stopped without cumulative effect.

Power to relax.

22. Where the State Government is of the opinion that it is necessary or expedient to do so, it may, by order for reasons to be recorded in writing, relax any of the provisions(s) of these rules with respect to any class or category of person (s) or post (s).

Repeal and Savings.

- 23. (1) On and from the date of commencement of these rules, the Himachai Pradesh Panchayati Raj (Appointment and Conditions of Service of Panchayat Sahayaks in Zila Parishads) Rules, 2014 published vide notification No 1911 HA(1)11/2010-I-6674-6815. dated 16-07-2014 shall stand repealed.
- (2) Notwithstanding such repeal, any appointment made or anything done of any action taken, under the rules so repealed, shall be deemed to have been validly made, done or taken under these rules.
