Applications are invited from localites (in and around Karaikudi) in the prescribed form for the temporary position of Part-time Physiotherapist (purely on temporary basis) in CSIR-CECRI Health Centre in its campus at Karaikudi on part time contract basis.

Qualification:	Bachelor Degree in Physiotherapy from any Government Institution or Government approved Institution.
Experience:	Relevant experience of 3 years.
Nature of Job:	To provide physiotherapy treatment to staff, their family members and pensioners of the Institute at CSIR-CECRI Health Centre daily for a duration of 3 hours in the morning or 2 hours in the morning & 1 hour in the evening during the working hours of the Health centre.
Emoluments:	Rs. 250/-per hour, subject to a maximum of three hours duty per day. Maximum honorarium @ Rs. 19,500/- per month for 3 hrs duty per day on all days (except Sundays & Closed Holidays)

Candidates will be called for interview through Google Meet. The date and time of interview will be notified in CSIR-CECRI website and also sent to candidates' Gmail ID.

Interested and eligible candidates should download the requisite application form from CECRI website. The application form duly completed in all respect and signed should be sent to <u>The Administrative Officer, CSIR-Central Electrochemical Research</u> <u>Institute, Karaikudi – 630 003. & reach this office by 22.02.2021 upto 5.30 pm through</u> <u>India post/courier.</u> Resume/Bio-date will not be considered as Application.

Candidates are required to send one set of photocopy of all relevant testimonials with selfattestation as indicated below along with the application-

- (i) Caste Certificate [for SC/ST/OBC (Non Creamy Layer)/EWS candidates as applicable] in the prescribed format issued by the Competent Authority as prescribed by Government of India.
- (ii) All Certificates/Testimonials in respect of DOB, educational qualifications.
- (iii) Compulsory Rotatory Residential Internship (CRRI) certificate.
- (iv) Experience certificate/Documents issued by the Employer in support of experience
- (v) Certificate of registration with State Physiotherapy & Occupational Therapy Council (or) Indian Association of Physiotherapy.
- (vi) Candidates should ensure that they submit all the documents mentioned above. In the event of failure to submit any of the required documents as mentioned above within the stipulated period, <u>candidature is liable to be rejected.</u>

GENERAL CONDITIONS:

- 1. <u>The position is purely temporary on Contract basis initially for a period of one year and</u> <u>may be curtailed or extended by one more year subject to the evaluation of performance</u> <u>of the candidate by the Competent Authority</u>. The contract may be terminated at any time by giving one month's notice by either side. The applicant(s) will have no claim implicit or explicit for consideration against any CSIR/CECRI post.
- 2. <u>In case candidate is having his/her own physiotherapy center registered under the</u> <u>Clinical Establishments (Registration and Regulation) Act, they may have to submit their</u> <u>experience certificate in their letter head and the physiotherapy center registration</u> <u>number with a copy of the physiotherapy center registration certificate.</u>

- 3. Incomplete applications (ie. without photograph, signature and all Semester Marksheets/Consolidated Mark Statement of UG & PG and applicable certificates etc.) will not be entertained and will be summarily rejected.
- 4. Candidates should specifically note that the applications received after the closing date for any reason whatsoever (such as envelopes wrongly addressed, delivered elsewhere, postal delay etc.) will not be entertained by CSIR-CECRI.
- 5. In case of receipt of large number of applications, the Selection/Screening Committee shall adopt its own criteria and shortlist the candidates for online interview in proportionate to the available vacancies.
- 6. Eligible/shortlisted candidates shall attend the Online Interview through Google Meet only.
- 7. Candidate shall attend the interview with decorum, with formal dressing and complete privacy and without any interference of other person. A closed and empty room may be preferred to take up the interview to avoid background noise interferences. He/she shall not indulge in any sort of unfair practices like assistance from third parties, electronic gadgets, books, etc.
- 8. Candidate shall not photograph/record any proceedings of the interview through any form. In case of any such activity found at later stage, his/her candidature for the post applied will be summarily rejected without prejudice to taking actions under extant laws governing such malpractices.
- 9. If the candidate does not have a valid gmail id, he/she should create a gmail id before submitting application. Details regarding Interview through Google Meet will be sent to the gmail id only.
- 10. In case of Universities/Institute awarding CGPA/SGPA/OGPA grades etc., candidates are requested to convert the same into percentage based on the formula as per their university/institute (copy of documented proof of the conversion factor must be attached).
- 11. CSIR-CECRI shall not be responsible if a candidate could not be interviewed online due to connectivity issues/ network error / low bandwidth at his/her end.
- 12. Shortlisted candidates will be provided with Google Meet code 10 minutes prior to interview in their respective Gmail ID. Shortlisted candidates will have to be readily available on the date of interview. (if any change is there, they will be intimated accordingly). In the event of non-response to our Gmail and SMS sharing Gmeet code, the candidate is forfeiting his/her opportunity and thereafter no requests for re-scheduling interview shall be considered.
- 13. The original documents including educational qualification, Birth/SSLC certificate, community and experience certificate, etc., in respect of selected candidate will be verified at the time of joining. Your joining in CECRI, Health Centre is subject to verification of certificates.
- 14. If any selected candidate provides any false information, his/her candidature is liable to be rejected.
- 15. It is the responsibility of the candidate to ensure his/her own eligibility for the post for which he/she has been selected in accordance with the advertisement. In case, it is detected later at any point of time, in future, even after appointment the candidate is not eligible as per prescribed qualification due to whatever circumstances, his/her candidature/appointment shall be liable to be cancelled/terminated as the case may be and no appeal against such cancellation will be entertained. Mere selection does not confer any right for permanent appointment in CSIR-CECRI.
- 16. The decision of the Director, CSIR-CECRI in all matters relating to eligibility, acceptance or rejection of applications and mode of selection will be final and binding on the candidates. No enquiry or correspondence will be entertained in this connection.
