- 1. The period of active service spent on pursuing Research Degree i.e. for acquiring Ph.D. degree simultaneously without taking any kind of leave may be counted as teaching experience for the purpose of direct recruitment/promotion to the post of Associate Professor and above.
- 2. Applicants for the post of Associate Professor and Professor should fill-up the Academic/Research Score Proforma (wherever applicable) as prescribed in the UGC Regulation- 2018 in Appendix II, Table-2 and send along with the application form. Each of the Academic/Research score card shall be supported by the documentary evidence, without which, no claim on account of Academic/Research score would be entertained. Applicants for the post of Assistant Professor are required to submit the Academic/Research Score Proforma, which can be downloaded from Jamia's website <a href="http://jmi.ac.in">http://jmi.ac.in</a>. Applications without Academic/Research Score Proforma shall not be considered.
- 3. After June 13, 2019, all the research papers must be published in the UGC-Care list journals only and a proof of the same should be enclosed with the application form.
- 4. The Academic score as specified in Appendix II (Table 3A) for Universities shall be considered for short-listing of the candidates for interview only, and the selections shall be based only on the performance in the interview.
- 5. Selection against temporary post/vacancy shall not confer on the appointee any right of permanent appointment/regularization.
