CIRCULAR

Subject: - Filling up the four (04) posts of Upper Division Clerk, in the National Commission for Scheduled Tribes by deputation.

It is proposed to fill up four 04 posts of Upper Division Clerks (General Central Service, Group 'C', Non-Gazetted, Ministerial in Level-4 of the pay matrix (Rs. 25,500-81,100/-) of Seventh Central Pay Commission in the National Commission for Scheduled Tribes, New Delhi and its Regional offices located in Bhopal/Raipur/Ranchi/Bhubaneshwar/Jaipur and Shillong on deputation basis initially for a period of three years which can be extended further as per rules of DoPT. The eligibility conditions for selection by deputation for the said post are given below: -

- 2. Officers under the Central Government or State Government or Union territory or Universities or recognized research institutions or public sector undertakings or autonomous or statutory organization: -
 - (a) (i) holding analogous post on regular basis in the parent cadre or department; or (ii) with five years' service in the grade rendered after appointment thereto on a regular basis in posts in level-2 in the pay matrix (Rs.19,900 63,200/-) in the parent cadre department; and
 - (b) Possessing the educational qualification and experience as under: -
 - (i) 12th class or its equivalent/qualification from a recognized Board or University.
 - (ii) Minimum typing speed of 35 words per minute in English or 30 words per minute in Hindi on computer.
 - Note (1) The departmental officials in the feeder category who are in direct line of promotion will not be eligible for consideration for appointment on deputation and similarly, deputationists shall not be eligible for consideration for appointment by promotion.
 - Note (2) Period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not to exceed four years.
 - Note (3) The maximum age limit for appointment by deputation shall not be exceeding fifty –six years as on the closing date of receipt or applications.

3. Duties attached to the post of Upper Division Clerk (UDC):

Dealing with all matters related to Administration and Accounts & Budget, etc. Up-dation of Service Books, preparation of all information and data related to audit: Hindi/English computer related typing work: Preparation of yearly, Half yearly, quarterly, monthly returns etc. Preparation of Reports & meetings related to Official Language receipts etc. any other work assigned by higher officers.

- 4. The pay of the selected candidate shall be regulated in terms of Department of Personnel & Training O.M. No. 6/8/2009-Estt. Pay-II) dated 17.06.2010 as amended from time to time.
- 5. Candidate selected for the post are likely to posted in Delhi or in any of the Regional Offices as per requirement and discretion of the Commission. Candidates may also indicate choice of their posting in the application.
- 6. Application (in duplicate) in the prescribed proforma (as in Annexure-I) of the candidate who fulfils the eligibility criteria and can be spared immediately together with the required documents mentioned as per Annexure-II may be forwarded to the Deputy Secretary (Admn.), National Commission for Scheduled Tribes, 6th Floor, Lok Nayak Bhawan, Khan Market, New Delhi within 60 days from the date of publication of the advertisement in the Employment News.
