**3% of vacancies will be reserved for persons with differently abled candidates (Locomotor Disability/Cerebral Palsy, Hearing Impairment, Low Vision) as per G.O. (P) No. 1/13/SJD dated 03/01/2013.**

**Note:** (i) Out of the 10 (Ten) vacancies now reported for the post of Lower Division Clerk from the Kerala State Co-Operative Coir Marketing Federation Limited, **05 (Five)** vacancies are apportioned for General Category. Vacancies if any, further reported will be filled by apportioning the same in the ratio of 1 : 1 between general category (Part I) and society category (Part II), and candidates will be advised accordingly. The first vacancy goes to General Category. The vacancies reported for this post from each Apex Society during the currency of this Ranked List and if the qualification is the same, will be apportioned in 1:1 ratio and the vacancies earmarked for General Category will be advised for appointment from this list. Separate notification will be issued under Part II for filling up the vacancies earmarked for Society Category. The rules of reservation as laid down in General Rules 14-17 of KS&SSR 1958 will be followed for appointment from both the lists.

(ii) The ranked list prepared and published by the Commission for the post shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list is published after the expiry of the minimum period of one year. Candidates will be advised for appointment against the aforesaid vacancies earmarked for the General Category during the period of currency of the list.

(iii) The selection in pursuance of this notification will be made on a statewide basis.

(iv) As per Rule 184 of KCS every person appointed to this post shall from the date on which he/she joins duty be on probation for a period of one year on duty within a continuous period of two years.

6. **Age** : 18-40, Only candidates born between 02.01.1981 and 01.01.2003 (Both dates included) are eligible to apply for this post . Other Backward Communities and SC/ST Candidates are eligible for usual age relaxation.

(For conditions regarding the age relaxation Please see part 2 of the General Conditions)

**Note:-**

For concession allowed in upper age limit subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para (2) of the General Conditions under part II of this Notification. Relaxation of age will be allowed to all provisional employees of the twenty nine Co-operative institutions mentioned in G. O. (P) No. 41/98 dated 09.03.1998 (whether they continue in service or relieved from service) who have been appointed through the Employment Exchange to the extent of their provisional service provided they possess a minimum service of one year in the provisional appointment. The maximum period of relaxation allowed to such persons will be five years. Once they get appointment on regular basis, the concession will not be available for further appointment to any other post. The candidates who are entitled to the above concession shall note the details there of in the respective column of the application and submit certificate (original) obtained from the Head of Office or Head of Department or Appointing Authority of the Co-operative Institutions concerned, when the Commission calls for. The certificate should contain all the relevant particulars such as the post in which the applicant has/ had provisional service, the scale of pay, name of the Co-operative Institution in which he/ she has/ had worked, the date of commencement of provisional service and the date of termination of the provisional service. It should also be noted in the certificate that the applicant is not holding regular appointment under the Co-operative Institution. The original certificate thus produced will not be returned to the candidate.

(ii) HDC or equivalent (HDC or equivalent of State Co-operative Union of Kerala or HDC/HDCM of National Council for Co-operative Training) or Successful completion of the subordinate (Junior) Personnel Co-operative Training Course (JDC) .

**OR**

- (C) B. Sc (Co-operation and Banking) Degree of Kerala Agricultural University.

- (2) A Certificate in Computer Application/Data entry issued by an Institution recognized by Government of Kerala or Government of India.

**Note:-** 1) Rule 10 (a) (ii) of Part II KS&SSR is applicable for this selection.

2) Those candidates who have claimed equivalency for qualification should produce the Government order proving the same at the time of certificate verification in order to consider as equivalent.

(3) If the caste of candidate is wrongly mentioned in the SSLC book, they should claim their original caste in their application and should produce Community Certificate/NCLC issued from concerned revenue authority and the Gazette Notification for the same at the time of certificate verification.

(i) Out of the 10 (Ten) vacancies now reported for the post of Lower Division Clerk from the Kerala State Co-operative Coir Marketing Federation Limited, 05 (Five) vacancies are apportioned for Society category. The first turn will be filled from General Category. The Vacancies for the same post if any, further reported will be divided in the ratio 1:1 and will be filled from the general category (Part I) and society category (Part II) alternatively. The vacancies further reported from this institution will be divided in the ratio 1:1 and vacancies for society category will be filled from the Ranked List published by the Commission in response to this Notification.

(ii) The ranked list prepared and published by the commission in response to this notification shall remain in force for a minimum period of one year and a maximum period of three years subject to the condition that the said list will not continue to be in force if a new list is published after the expiry of the minimum period of one year of this list.
