1. **Qualification:** - MBBS with post graduate Degree/Diploma/DNB in any specialty, willing to work in medicine/critical care. In case of non availability of eligible candidates, Non PG candidates having three years experience in medicine may be considered. Candidate should have a valid registration with Delhi Medical Council.
2. **Emoluments:** - As per 7<sup>th</sup> CPC Pay Matrix Level 11, Pay Rs. 67700 plus allowances as admissible under the rules.

**Terms and Conditions:-**

- i. In case no candidate from particular category is available the seat may be filled from any other category.
- ii. The engagement will be purely on Adhoc basis for 44 days only.
- iii. No leave of any kind allowed shall be granted during this period.
- iv. No application fee shall be charged.
- v. In case of absence without any intimation, the engagement shall be terminated without assigning any notice.
