Background: Tata Trusts launched "Reviving the Green Revolution (RGR)" Initiative in Punjab in 2002 with an objective to promote diversification in agriculture thus, making it sustainable and economically profitable, especially for small and marginal farmers. In order to successfully use agriculture as a vehicle of livelihood enhancement, the RGR Initiative operates with due attention to the development of new agro-technologies and their adoption by farming communities. The overall success of the Initiative, coupled with major expansion and coverage under projects, encouraged the Trusts to scale up interventions through a registered centralized organization with dedicated team.
