- e) Latest Caste Certificate issued by the Competent Authority not Earlier than six months.
- f) Copy of experience certificate if any, if employed in Govt. Services, Relieving Letter from the HOD of the respective Department.
- g) Copy of signed online application
- h) Two passport size photos.

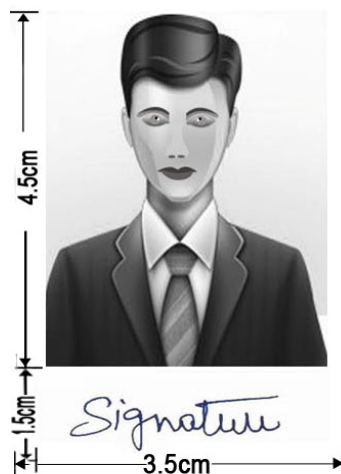

- i) Paste the **Colour Photo** on any white paper as per the above required dimensions. Sign in the Space provided for signature. Ensure that the signature is within the box.
- ii) Scan the above required size containing photograph and signature. Please do not scan the complete page.
- iii) The entire image (of size 3.5 cm by 6.0 cm) consisting of the photo along with the signature is required to be scanned and stored in **\*.jpg** format on local system.
- iv) Ensure that the size of the scanned image is not more than 50 KB.
- v) If the size of the file is more than 50 KB, then adjust the settings of the scanner such as the dpi resolution, no. of colors etc., during the process of scanning.
- vi) **The candidate has to sign in full in the box provided. Since the signature is proof of identity, it must be genuine and in full; initials are not sufficient. Signature in CAPITAL LETTERS is not permitted.**
- vii) **The signature must be signed invariably made by the candidate and not by any other person.**
