The candidate (s) shall be allowed to face the interview subject to fulfillment of their eligibility criterion in all respect after completion of verification of documents.

It is also made clear that the candidature of these candidates for the recruitment is purely provisional. The candidature is liable for rejection in the event of inadequacy/ deficiency found at any stage during or after the selection process and is subject to fulfillment of the terms and conditions laid down in the advertisement. Mere participation in the document verification does not reserve any right for selection.

The candidates are advised to report in the office of the Commission **half an hour before the commencement of verification** on the scheduled date & time as mentioned above.
