9. ELIGIBILITY CRITERIA:

- (i) The candidate must be a citizen of India.
- (ii)The candidate must fulfill the educational qualification, age, experience etc. as stipulated in this advertisement.

10. RESERVATION BENEFITS:

- (i) Reservation benefits will be available to the SC,ST,OBC,EWS, Persons with benchmark disabilities& Ex-servicemanCategory candidates in accordance with the latest instructions/orders/circulars issued by Central Govt from time to time
- (ii) Candidates who wish to be considered against reserved vacancies and /or to seek age relaxation,must be in possession of relevant certificate issued to them by the competent/notified authority (inprescribed format required for employment under Central Govt) on or before the closing date of application; otherwise their claim for reservation shall be rejected.

(c) Appointed candidate will be employee of the Cantonment Board Ahmedabad and not of Central Govt.

(g) The appointing authority shall draw a reserve panel/waiting list in addition to the number of candidates selected as per the notified vacancies. The reserve panel/waiting list shall be valid for a period of one year from the date of declaration of result and the vacancies arising due to: non-acceptance of the offer of appointment, candidates not joining the post after acceptance of appointment or the candidates not being found eligible for appointment after verification of documents/ certificates or due to resignation of selected candidates within one year of joining the post, shall be filled up from this reserve panel/waiting list.
