2. The applicants applying in response to this advertisement should satisfy themselves regarding their eligibility for the aforesaid post and must fulfill all the eligibility criteria on or before **10.01.2022**, failing which their application will be rejected.

(iv) No age relaxation would be available to SC/ST/OBC/PWBD candidates applying for unreserved vacancies.

**NOTE :** i) Candidates applying under any of the reserved category posts, viz. SC/ST/OBC/EWS/PwBD will be considered subject to Caste Certificate issued by the appropriate/ competent authority on the prescribed format. Community should be clearly and legibly mentioned in the certificate. OBC candidate's eligibility will be based on the caste(s) borne in the Central List of Government of India. OBC candidate(s) should not belongs to Creamy Layer and their sub-caste should be match with the entries in Central List of OBC, failing which their candidates will not be considered under any of the applied reserved category post(s).

Duly constituted Standing Selection Committee will conduct the selection process for all the posts. AIIMS, Raebareli reserves the right to conduct ***a written test also in cases where the number of applicants in a particular department is 30 or more.***
