

HARYANA PUBLIC SERVICE COMMISSION BAYS NO 1-10, BLOCK-B, SECTOR 4, PANCHKULA

RESULT

On the basis of Recruitment Test for the Post of **Dental Surgeon** (Class-II) in Health Department, Haryana conducted by the Haryana Public Service Commission on 26.09.2021, the candidates, three times the number of vacancies along with bracketed candidates, if any, bearing the following Roll Nos. have been declared qualified for Viva-Voce provisionally, subject to the fulfillment of all eligibility conditions.
