#### I. TERMS AND CONDITIONS FOR APPOINTMENT

- 1. **Name of Post**: Drone Pilots for Remotely Piloted Aircraft Systems.
- 2. **Period of Contract Appointment:** 3 Years extendable by another period of 3 years based on assessment of performance.
- 3. **Remuneration**: The lump sum monthly remuneration payable will be Rs 50,000/- with annual increase indexed to inflation on completion of each year based on assessment of performance.

#### II. GENERAL INFORMATION

- 1. Applicant should be citizen of India.
- 2. Applicantshould not be less than 18 years of age. Self-attested copies of passport/PPP ID/Birth Certificate required to be submitted as proof of identification and proof of age.
- 3. Applicant shall submit a medical fitness report from a Govt. Hospital prior to his joining.
- 4. Incomplete applications will be summarily rejected and application link on the designated web portal will be disabled immediately after the date and time notified as the last date and time. No request in this regard shall be entertained.
- 5. Applications shall accepted only through CRID (DRIISHYA) Online Recruitment portal. Application by hand shall not be accepted.
- 6. Modification of the application is not admissible after submission of form. Hence, candidates should be very careful while filling the application.
- 7. The rules and instructions of the State Government on reservation shall apply for the appointment.
- 8. All educational qualifications should have been obtained from a University/Institute recognized by UGC/AICTE/Central Govt. only.
- 9. Candidates employed in Government / Semi Government Organizations / Autonomous Bodies, PSUs, should bring NOC from employers at the time of joining.
- 10. Canvassing in any manner would entail disqualification of the candidate.
- 11. CRID (DRIISHYA) reserves its right to restrict number of candidates for the written test &personal interaction to a reasonable limit, on the basis of qualification and/or experience higher than those prescribed in this advertisement.
- 12. Names of the short-listed candidates for the written test and personal interaction will be displayed on the portal. No individual Call Letter/Admit Card will be sent.
- 13. Number of vacancies is purely provisional which may be increased/decreased at the sole discretion of the CRID (DRIISHYA).

- 15. No Travelling Allowance will be paid for appearing in the written test.
- 16. The location of written test will be notified on CRID(DRIISHYA) recruitment portal.
- 17. All further information regarding the recruitment will be provided through the recruitment portal only. CRID (DRIISHYA) will not be responsible in any manner if a candidate fails to visit/access the website in time. Candidates are requested to regularly visit the recruitment portal i.e. <a href="CRID recruitment portal">CRID recruitment portal</a> for updated information regarding the recruitment.
- 18. The decision of the CRID (DRIISHYA) in all matters will be final. No correspondence /interim inquiries will be entertained from the candidates in connection with the process of selection. Any dispute with regard to the recruitment process will be subject to Courts/Tribunals having jurisdiction in Panchkula only.
- 19. Candidates selected for appointment will have to produce original documents in support of all the particulars mentioned in their application form regarding their date of birth, reservation category, educational qualification, experience and other claims.
- 20. Selected candidates will be appointed for a contractual tenure of 3 years which will be extendable or curtailed as the circumstances so require and also based on the performance of the selected candidate.
- 21. Candidates may be posted and/or transferred to any department at any time during service career at the discretion of CRID (DRIISHYA).
- 22. Candidate will be required to go to field for drone flying anywhere in Haryana or outside as may be decided by the competent authority.
- 23. Work Experience, wherever required shall be recognized only if the experience is in the area of relevance for the post.
- 24. Decision of CRID (DRIISHYA)shall be final in the matter of recognizing work experience.
- 25. Screening of candidates shall be based on Written test. Minimum cut-off to qualify for personal interview shall be communicated later.

#### Desirable Qualification.

- 1. The applicant may submit a certificate of training of appropriate category of experience in piloting unmanned aircraft system and class of unmanned aircraft from an authorized training organization in accordance with the syllabus specified by the Director General Civil Aviation.
- 2. The applicant may submit Remotely Piloted Aircraft License granted by Director General of Civil Aviation for the specific category of unmanned aircraft systemand specific class of unmanned aircraft.



#### III. KEY TERMS OF APPOINTMENT

The following are the key terms of appointmentsDrone Pilotsfor Remotely Piloted Aircraft Systems:

#### a. Validity of offer of appointment

The offer of appointment to any candidate shall be valid only for one month from the date of communication of the offer of appointment. Any selected candidate would need to join within two months of the offer of appointment. The offer of appointment would be communicated to the e-mail provided by the applicant.

#### b. Age Limit and Tenure of Appointment

The tenure of appointment of a person appointed on contractual basis shall be three years initially extendable for another period of 3 years subject to assessment of performance ortill he attains the age of fifty-eight years, whichever is earlier.

#### c. Remuneration payable to staff.

The lump sum remuneration of Rs. 50,000/- per month will be paid. The candidate shall be paid remuneration only from the date he/she completes the training for Unmanned Aircraft Systems (UAS) successfully.

#### d. Training and Confirmation.

On selection candidate will be required to undergo UAS flying training from a recognized institute as decided by the CRID (DRIISHYA). CRID (DRIISHYA) will further facilitate RAPS license from DGCA and also bear the cost of training. In case the candidate fails to obtain the licence within two months of the appointment, then the offer of appointment shall stand withdrawn.

#### e. Eligibility for leave

Persons appointed on contractual basis shall be entitled for 10 days casual leave in each calendar year.

#### e. Travelling Allowance

The selected candidate may be required to travel across Haryana or outside Haryana for CRID (DRIISHYA) related duty. Person appointed on contractual basis shall be eligible for travelling allowance equivalent to that permissible to a Class II Government servant provided that such person is to travel on duty beyond the limits of his district of posting



## IV. PROCEDURE TO APPLY ONLINE

#### How to apply

Before applying online, a candidate is required to have: -

- 3. Recent passport size photograph (JPG / JPEG file format less than equal to 100k)
- 4. Passport or PPP ID or Birth Certificate
- 5. Curriculum Vitae of the candidate (Word/PDF format less than equal to 100kb)

#### **Candidate Selection Procedure**

- 1. Final selection for all the posts will be based on written test and personal interview only. The written test shall have a weightage of 80% of the total marks. The weightage of Academic Qualification, Experience shall be decided before the date of the written test and notified on the recruitment portal for each position.
- 2. Medium of written testshall be English only
- 3. Written Test can be conducted anywhere in Haryana at designated agency site. Test centre details will be notified on CRID(DRIISHYA) recruitment portal.
