# TERMS AND CONDITION GOVERNING THE APPOINTMENT OF ADVISOR (ESTATE & PROPERTY) RETIRED FROM REVENUE DEPARTMENT OF STATE GOVT. ON CONTRACTUAL BASIS

- The appointment is purely on contract basis for a period of 03 months. with effect from the date of joining. Thereafter, the contract will lapse automatically.
