**REQUIREMENT OF FIDIC CONTRACT EXPERT ON CONTRACT BASIS**

National Capital Region Transport Corporation (NCRTC)- a Joint Venture Company of Govt. of India and States of Delhi, Haryana, Rajasthan and U.P, under the administrative control of Ministry of Housing and Urban Affairs, is mandated for implementing the Regional Rapid Transit System (RRTS) in National Capital Region (NCR), ensuring a balanced and sustainable urban development through better connectivity and access. The RRTS will be a new, dedicated, high speed, high capacity, comfortable commuter service connecting regional nodes in NCR. It will provide reliable, high frequency, point to point safe regional travel at high speed for relatively longer distance with fewer stops.

The technology chosen would allow covering distances of 100 km. in an hour with scheduled stoppages. The system would also ensure the convenience of quality last mile connectivity, addressing the needs of all categories of travelers on the network. The corridors being developed under RRTS Phase-1 are **Delhi- Ghaziabad- Meerut, Delhi- Gurugram-SNB-Alwar and Delhi- Panipat**. Once operational, RRTS will be the fastest, the most comfortable and the safest mode of travel in the NCR.

NCRTC invites applications from Civil Engineers having varied experience in project implementation/ contract management/ procurement and have worked with Govt. organisations/ reputed private sector companies. The detail of the post is given below-

<b>Qualification, Eligibility and Experience</b>	<b><u>Qualification-</u></b> -Bachelor's Degree in Civil Engineering. <b><u>Eligibility/ Working level-</u></b> -Should have worked at the level of General Manager `(E8) in Govt. organization or, Working/ have worked in a reputed private sector infrastructure company National/ International) at senior level (General Manager/Vice-President) with minimum pay-package of Rs.40 lakh per annum. <b><u>Experience-</u></b> -Should have minimum 20 years' varied experience of contract management/ project management/ implementation of large infrastructure projects in India/ abroad. He should have sound techno commercial knowledge and domain expertise of large infrastructure projects based on FIDIC conditions of contract or funded by multilateral/ bilateral international agencies.
<b>Pay &amp; benefits</b>	As per Corporation's policy.
<b>Term of employment</b>	-For a period of 02 (Two) years. -During the contract period, the employment can be terminated by giving 15 days' notice without assigning any reasons.

**Other terms and conditions of NCRTC shall be applicable.**

### **PHYSICAL & MEDICAL FITNESS:**

The applicant should not only be suitable in related field, but also be physically and medically fit enough to work at project sites.

### **SELECTION PROCESS:**

(a) After scrutiny of the applications, candidates will be shortlisted on the basis of eligibility criteria i.e. experience, desirable qualification etc. and will be called for interview.

(b) Management may relax any of the condition/s, in accordance with the response to meet the requirement.
