- i.) In addition to the pay above, the Medical Officers will be entitled for transport allowances with DA on transport allowance as per rules. DA on transport allowances will be revised from time to time as per rules.
- ii.) The amount of remuneration for Medical Officers will be revised automatically in accordance with proportionate change in rate of pay and allowances of equivalent category of employees at regular intervals as per Govt. policies. Accordingly, whenever there is revision in rate of Dearness Allowance, the same shall be made effective from the date of notification of Govt. orders. However, arrears of pay & allowances shall not be admissible for any rate revision with retrospective effect.
- c) No other allowances will be paid in addition to the consolidate remuneration.
- d) No Private practice is allowed during the tenure of service in ESIC.
- e) Retirees from Central/State Govt/PSU from the equivalent posts are eligible to apply. Persons working in recognized/approved Private Medical Institutions fulfilling eligibility criteria for the post may also apply.

3. TERMS OF CONTRACT:

- (a) **For Professor/Associate Professor/Assistant Professor** :-Selected candidates shall be appointed on purely contractual basis for a period of three year at the outset, and may be extended for a period of two years. The maximum tenure for such engagement will not exceed five years or 70 years of age of the faculty, whichever is earlier, in accordance to ESIC HQRS memorandum L-11/12/3/2018/ Corporate Cell/ME Cell (PF)/288 dt. 28.10.2020. Candidates completing 5 years of contractual tenure will not be entitled for gratuity or any other pecuniary benefits.
