Experience Profile: Should have adequate experience and demonstrated competency in mine planning, developing and operation of the mines (from green field projects to operation of mines), preferably open cast mines with an aptitude of good networking and stakeholder management.

Job Profile: As CEO (Mining), the incumbent will be leading the Mining venture of the organization and will be responsible for overall management of all the mining projects of NTPC. The incumbent will be responsible for outlining project plans, setting project plans, setting projects goals/deadlines, evaluating performance and will ensure timely implementation of the operational plans of the mine, monitor and report progress and also recommend corrective measures.
