The filled-in applications along with necessary documents shall be submitted at office of the District Coordinator of Hospital Services (DCHS), District Hospital, Vizianagaram.

Selection to the posts will be on the basis of final general merit cum rule of reservation. PARA:4::Reservation to Local candidates:

Note-2: The candidates who claim service weightage should submit Original service certificates in prescribed proforma duly issued by the competent authority along with copy of appointment orders issued by competent authority. Those who fail to submit the Original service certificate in prescribed proforma duly issued by the competent authority with appointment orders by competent authority will not be allowed service weightage.

PARA:8:: Tenure of appointment and important conditions:

The tenure of the contract/outsourcing initially one year from the date of joining in the post and may be extended for further period as per the instructions issued by the Government from time to time.

PARA:9:: Debarment:
