CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **02 (Two)** positions of **PROJECT ASSOCIATE- I** initially for a period of **10 Months** or till the project is over on a temporary contractual basis in the project entitled “**Disinfestation and management of phosphine resistance insect pests: Design and development of multi-fume grain storage system**” (**MLP-300**) funded by **CSIR** tenable at the Department of **Food Protectants & Infestation Control**, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: First Class M.Sc. (Entomology / Zoology / Life Science / Food Science / Biotechnology).

Job Requirements:

1. Laboratory R&D work with respect to the project objectives.
2. Field sample collection from different regions with respect to the project objectives.

Emoluments: 31,000/- plus HRA to Scholars who are selected through National Eligibility Tests (CSIR-UGC NET, GATE etc.) **Rs.25,000/- plus HRA** to Others per month.

1. Candidates should not have exceeded **35** years of age as on **03-06-2022** i.e. the last date of receiving the applications.
2. The engagement of **PROJECT ASSOCIATE - I** is exclusively for the above-mentioned research work.
3. The engagement will be contractual and purely on temporary basis for a period of 10 months or co-terminus with the project, whichever is earlier.
