## NOTICE

The Mediation Cell attached to the District Consumer Disputes Redressal Commission proposes to prepare a panel of Mediators for mediation in the Consumer Cases. Applications are invited from the eligible Indian Nationals in terms of Section 75 of the Consumer Protection Act, 2019, the Consumer Protection (Mediation) Rules, 2020 and the Consumer Protection (Mediation) Regulations, 2020, who, satisfying the following criteria:

- (I) is a retired judge of the Hon'ble Supreme Court of India;
- (ii) is a retired judge of an Hon'ble High Court;
- (iii) is a retired Member of a Consumer Commission;
- (iv) is a retired District and Session Judge, a retired Additional District and Session Judge or other retired Member of the Higher Judicial Services of a State;
- (v) is a retired Judicial Officer, having experience of not less than ten years;
- (vi) is an advocate with a minimum experience of ten years at Bar;
- (vii) is a mediator empanelled with the Mediation Cell of the Supreme Court of India, High Court or a District Court;
- (viii) is a person having experience of at least five years in mediation or conciliation;
- (ix) is an expert or other professional with at least fifteen years' experience or a retired senior bureaucrat or retired executive.
- 2. The terms and conditions of the Mediators, including the fee payable to the Mediators, shall be, as referred, in the relevant provisions of the Consumer Protection Act, 2019, the Consumer Protection (Mediation) Rules, 2020 and the Consumer Protection (Mediation) Regulations, 2020.
- 3. The eligible persons, desirous for empanelment as Mediators, shall send their applications in such manner that their applications, complete in all respect, so as to reach the office of the President, District Consumer Disputes Redressal Commission, NCMS Campus, Charing Cross, Udhagamandalam, The Nilgiris on 10.06.2022 upto 5:00 P.M.. Applications received there after for reasons whatsoever, shall be rejected.
- 4. The Selection Committee can adopt any criteria for scrutiny and short listing of applications and for determining its procedure for making its recommendations, after taking into account the suitability, integrity as well as relevant experience of the candidates.
- 5. The eligible persons, desirous for empanelment as Mediators, may submit their applications in the format provided at Annexure-I.
