2. Three passport size photographs same as uploaded in the online application form;
3. Duly filled in and attested "**Attestation Form**" and duly filled in "**Bio-data Form**" (to be downloaded from the website of the Commission).
4. HSC or equivalent certificate in support of declaration of age issued by the concerned Board/Council;

5. Post-Graduation certificate/Master's Degree in the subject concerned in respect of educational qualification prescribed;
6. B.Ed. certificate;
7. Mark-sheets in support of all the Examinations (HSC, Intermediate/+2, Graduation/+3, Post Graduation & B.Ed.) including fail marks, if any, issued by the concerned Board/Council/University;
8. Degree or Diploma certificate in Computer Application in respect of educational qualification prescribed;
9. Odia Test pass certificate;
10. Caste Certificate claim as S.T./S.C./S.E.B.C. wherever applicable;
11. Permanent Disability Certificate (including percentage of permanent disability i.e. 40% and more);
12. Ex-Servicemen are required to attach copy of Discharge Certificate issued by the Commanding Officer of the Unit last served. They must submit an affidavit undertaking that he/she has not been appointed against any civil post after retirement from military service, wherever applicable;
13. Sports Persons certificate issued by the Director of Sports Odisha;
14. Any proof of Identity.

NOTE – It is also made clear that the candidature of these candidates for the recruitment is purely provisional. The candidature is liable for rejection in the event of inadequacy/deficiency found at any stage during or after the selection process and is subject to fulfillment of the terms and conditions laid down in the advertisement.
