- 1. **Essential qualifications:** M.S.(Pharm.) Medicinal/Pharmaceutical Chemistry OR M.Pharm Medicinal/Pharmaceutical Chemistry, M.Tech (Pharm.) Process Chemistry, M.Sc. - 5. **Tenure of the post:** The position is purely temporary, initially for a period of **1 Year**, extendable till the duration of the project based on the performance of the candidate.
