2. TERMS OF CONTRACT:

- a) Selected candidates shall be appointed purely on contractual basis for the maximum period of one year.
- b) The contractual engagement may be terminated / discontinued on either side after giving one-month prior notice to this effect without assigning any reason.

Residential plot of 200 sq. yards and above in areas other than the notified municipalities. IV. The property held by a "Family" in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status.
