**Educational Qualification/General Terms & Conditions for Hiring of Medical Practitioner:-**

**I. The Educational Qualification for Medical Practitioner:-**

MBBS Degree from MCI recognized Medical College of India is the basic qualifying requirement. He/She should be a registered Medical Practitioner. At the time of entering the Contract/agreement, the Medical Practitioner shall produce original certificates of his/her qualification, Medical Registration Certificate with the National/State Medical Council and proof of date of birth along with character certificates from two Gazetted Officers of the Central/State Government.

**Nature of Duties:** The Hired Medical Practitioner shall attend to the entire normal task, which any Regular Medical Practitioner is conventionally doing. He/She will also attend emergencies/disasters and accidents. Night duties are to be performed on as and when required basis even on Sunday and Holidays, against which off will be given on next day,

Only Indian Nationals are eligible to appear in the interview. Candidates are required to bring all original documents in support of their qualification and relevant documents like Voter ID, PAN Card etc., along with two recent passport size photographs.

The tenure of the contract shall be for 06 months only. The assignment is purely temporary in nature which may be terminated/ foreclosed with 07 seven days notice from either side.

Eligible and Interested candidates having requisite qualification are directed to reports to **Medical Officer I/C, Ordnance Factory Hospital, HVF Hospital, Avadi, Chennai-54 on 30/08/2022(Tuesday) at 09.00am sharp. The candidates are requested to bring all original certificates of his/her qualification, Medical Registration Certificate with the National/State Medical Council and one set of Xerox copy of the educational qualification duly attested by the Central/State Govt. Gazetted Officer.**

## **II. General Terms & Conditions for Hiring of Medical Practitioner:-**

1. The contract/agreement shall be entered into for 6 months or less from the date of entering into contract/agreement. Period of hiring is not extendable on any grounds. 2<sup>nd</sup> term may be considered against clear vacancy and satisfactory work. The contract should be signed between the hired professional and MO I/C as per the terms and conditions laid down by Ordnance Factory Board. A particular individual should not be hired more than once in a calendar year. However in case of retired Doctors subsequent contracts may be allowed with prior sanction of Ordnance Factory Board.
2. The full-time Hired Medical Practitioner who enters into agreement with the factory will not have any claim or right for his/her continuity in service or automatic extension of contract/agreement.
3. During the validity of the agreement the Hired Medical Practitioner will be at liberty to terminate the agreement for betterment of his/her career or any other grounds by giving **seven** days notice to the Factory. The Factory can also terminate the agreement at any time during the tenure by giving **seven** days notice without assigning any reasons what so ever. Agreement shall also be terminated, if the Hired Medical Practitioner is found to be mentally or physically incapacitated or incapable of discharging his/her duties.
4. The Hired Medical Practitioner shall undergo a Medical Examination at the Factory Hospital, before the contract is entered into, for his/her fitness to perform the work awarded to him/her. PVR is mandatory if the hired Medical Practitioner is to be posted inside the Factory premises.
5. Normally Sundays and National Holidays (Republic Day, Independence Day & Gandhi Jayanti) shall be off. If they are called for work on these days they will be granted Off in lieu of that.
6. The Hired Medical Practitioner will not be provided with any transport/transport arrangement. The Hired Medical Practitioner will not be entitled for any free medical treatment at O.F. Hospitals except First Aid in case of Emergency.
7. The Hired Medical Practitioner shall attend to all the normal tasks which any Regular Medical Practitioner is conventionally doing. He/She will also attend emergencies/disasters and accidents.
8. The Hired Medical Practitioner shall provide his/her services as DMO minimum once in week and he/she will get Off the next day as done/availed by regular MOs of IOFHS at station.
9. The Hired Medical Practitioner can issue SICK/UNFIT certificate upto a maximum period of 03 days which should be countersigned by a regular MO. Hired Medical Practitioner will normally not issue **FITNESS** Certificates.
10. The Hired Medical Practitioner will not have any financial powers and shall not perform any administrative work like Pre-Employment Medical Examination etc. The Hired Medical Practitioner shall not make any administrative Medical Recommendations normally, if he/she does so it should be approved by MO I/C.
11. The Hired Medical Practitioner will not refer patients to other Hospitals, if he/she does so it should be approved by MO I/C.
12. The Hired Medical Practitioner cannot write the Annual Performance Assessment Report(APAR) of any category of Staff.
13. The Medical Officer Incharge OFHHVF reserves the right to modify/alter the process due to any directives of court/CAT case or as per instructions from DOO(C&S)/Ministry of Defence without issuing any further notice or assigning any reason. The decision of MO I/C OFHHVF will be final and no appeal will be entertain against this issue.
