We are looking for full stack Java developers to join our team. As a mid/senior level developer you should be comfortable around both backend stack and front end stack coding languages, development frameworks and third party libraries integration. You should also be comfortable with postgres DB integration with backend applications, with large volumes of data transactions.

- Creating servers and databases for functionality.
- Integration and adding feature to existing backend applications.
- Seeing through a project from conception to finished products.
- Designing and developing API's
- Documentation and cross-platform optimization for mobile phones.

- Design, develop, test, deploy, maintain and improve software and systems.
- Make architecture decisions for large product features or new system.
- Assist other team members of the team in their roles.
- Participate in our agile development process.

### **Job Requirement**

- 5-10 years of experience in software/applications development using Java stack, maven, springboot.
- Good knowledge of - Spring, Spring boot, Java/J2EE, Hibernate, Database – Postgres/RDBMS, Apache Kafka, Elastic Search.
- In depth understanding of data structures and algorithms.
- Hands on experience and working proficiency in developmental tools like Swagger2.0, Json, postman, Yaml, Open API contract, Git, Junit, CICD pipeline
- Experience in UI development using react/angular and UI/UX concepts.
- Experience in working with postgresQL,
- Experience in AWS-cloud/Azure/Google cloud technologies with micro service architecture and knowledge on Elasticsearch, kafka, API gateway would be an advantage.
- Experience of working on high data volume processing applications.
- Integration exposure with third party applications, Wallet and Payment gateway (Nice to Have)
- DevOps tools knowledge - Jenkins/Docker/Kubernetes (optional/added advantage)

- The candidate has to scan his full signature, since the signature is proof of identity, it must be genuine and in full: initials are not sufficient. Signature in CAPITAL LETTERS is not permitted. The signature must be signed only by the candidate and may not by any other person.

Applicants should be careful in filling- up the application form at the time of Submission. **If any lapse is detected during the scrutiny, the candidature will be rejected even though he/she comes through the final stage of recruitment process or even at a later stage.**
5. The applicant should not furnish any false, tampered, fabricated information or suppress any material information while filling up the application form. If the particulars furnished in the Online application form do not tally with the original documents produced by the Candidates his/her candidature will be rejected.
6. IKM reserves the right to fill or not fill the post advertised.
7. Only Post- Qualification experience of candidates/applicants will be considered.

IKM may send intimation to download call letters for Written test/Group discussion/Proficiency Test/Interview through the registered e-mail ID.
