It is for information of all concerned that the Commission have decided to conduct the Physical verification of original certificates & documents and Viva Voce test simultaneously in respect of **79** candidates (bearing following Roll Nos.), selected in the written examination, for recruitment to the post of **Assistant Horticulture Officer**, pursuant to Advt.
