1). Applications are invited from the eligible Candidates for filling up of the (51) Mid Level Health Providers Posts on Contract basis under National Health Mission (NHM).

Filled in Application Form along with all essential Certificate copies duly attested shall be submitted in person at O/o District Medical & Health Officer, Jagtial from **07-09-2022 to 17-09-2022**.

- 2) Selection shall be done as per the following priority:
- (i) MLHP Posts of Health Wellness Centers that are located in Municipal Areas should be filled with MBBS/BAMS Doctors only with preference being given to MBBS Doctors.
  - (ii) MLHP Posts of Health Wellness Centers that are located in non Municipal Areas (Rural), the recruitment shall be done in the following order of priority:
    - (a) Doctor (MBBS/BAMS) with preference being given to MBBS
    - (b) Staff Nurse with B.Sc.(Nursing) who have graduated from the academic year 2020 onwards (or) Staff Nurse with B.Sc. (Nursing) /GNM who completed before the academic year 2020 and who completed (6) months Bridge Programme in Community Health (CPCH)
- 3) In the Health and Wellness Centers located in Municipal areas, the positions will first be filled up with MBBS Doctors as per eligibility, after exhausting the MBBS Doctors, these vacancies will be filled with BAMS Doctors as per eligibility.
- 4) In the Health and Wellness Centers located in non-municipal areas the positions will first be filled up with MBBS Doctors as per Eligibility, after exhausting the MBBS Doctors, these vacancies will be filled with BAMS Doctors as per eligibility. If no doctors are available, then these positions can be filled up by Staff Nurses as per the eligibility as mentioned in para 2(b).
- 5) **Age:** as prescribed by the Government the minimum and maximum age is (18) years and (44) years respectively. The upper age limit prescribed above is however relaxed in the following cases:

9) **Selection Procedure:**

- Selection will be done on the combined percentage of Marks obtained in all years of MBBS/BAMS/B.Sc(Nursing)/GNM

- (iii) Rule of Reservation shall be followed as per Government Orders from time to time.
- (iv) Presidential Order -2018 has to be followed, as per PO-2018 MBBS & BAMS Doctors are Multi Zone-I posts and Staff Nurses are Zone-II (Basara) posts.
- (v) Since Health Wellness Centers located in Municipal Areas are to be filled up by only MBBS/BAMS Doctors, they will be permitted to opt for either Urban or Rural HWCs or both.
- (vi) Notifications shall be issued through District Selection Committee (DSC)
- (vii) The selected MBBS and Staff Nurse candidates have to undergo two weeks of induction training. The selected BAMS candidates have to undergo Bridge Course Programme in Community Health (CPCH)
- (viii) After selection process is completed, postings will be issued to the identified Health and Wellness Centers as per merit cum options.

**Note: The District Selection Committee will have to right to postpone this Notification temporarily or permanently cancel at any stage.**
