Applications are invited from the Technicians working in all the grades of Civil Engineering department to form a panel of Intermediate Apprentices to fill up the 15% quota vacancies of Junior Engineer (Works) in Level-6 of RSRP Rules 2016 in the Civil Engineeing department, who fulfill the conditions mentioned below.

2. Eligibility conditions;

(a) Educational qualification:

The volunteering candidates working as Technicians in the Civil Engineering department should posses the educational qualification of National Apprenticeship Certificate/National Trade Certificate issued by the National Council for Vocational Training (or) Possession of Higher Secondary course Certificate under the 10+2 system (Science stream) (or) its equivalent with any of the Science subjects (or) Degree or Diploma in Engineering.**

** In terms of Railway Board's letter No.E(NG)-II/2010/RR-1/17 Dated 08.12.2011 (RBE No.165/2011), the diploma/Degree in Engineering obtained through distance mode except AMIETE will not be considered as eligible.

(b) Age: 4

Must not be more than 47 years as on 21.07.2022 as per Rly Board's letter No.E(NG)I-1999/PM7/7 dated 09.06.2010 (RBE No.85/2010).

(c) Service:

A minimum of 03 (Three) years continous satisfactory service as Technician Gr.III and above in the Civil Engineering department.

- NOTE 1: Training period will not be counted towards the minimum 03 (three) years period except for the directly recruited Technician Gr.III who possess technical qualification and have undergone 6 months training.
- NOTE 2: Those who are working in an ex-cadre post but have a lien a Technician/Civil Engineering department will be eligible, provided they satisfy the other conditions.
- NOTE 3: Those who are working on adhoc basis are not eligible to apply.

3. Mode of Selection:

The above selection consists of a written exam and the final empanelment will be on merit based on the marks secured by the employees in written exam and record of service. There will be no weightage for seniority in terms of Railway Board's letter No.E(NG)I-2008/PM/7/4/SLP dated 19.06.2009 and No.E(NG)I-2008/PM/1/26 dated 06.02.2014.

The number of candidates to be empanelled will be drawn as per merit with reference to marks obtained by the candidates in 'Professional ability' and 'Record of Service'. Those securing less than 60% in 'Professional ability ' and 60% in ággregate, will not be considered eligible for inclusion in the panel. Further, the service records of only those candidates who secure a minimum of 60% marks in professional ability, shall be assessed. Since the final panel has to be drawn on the basis of merit, there will be no scope for provision of placement of candidates who secure 80% or more marks, classified as 'Outstanding', on the top of the panel.

4. Written examination:

The written exam in connection with the above selection will be advised in due course. However, the candidates may treat this notification itself as an alert notice and be in preparedness to appear in short notice.

The candidates will have an option to answer the question paper in Hindi/English. Those who opt for appering the exam in Hindi should indicate their choice in writing in the application itself at the relevant column provided therein.

All questions will be 100% objective type and will be multiple choice only, as per the instructions contained in Railway Board's letter No.E(NG)I/2018/PM1/4 Dated 14.12.2018.

There will be negative marking for incorrect answers. One third of the marks allotted for each question will be deducted for wrong answers.

Questions related to Official language policy & Rules will carry 10% of the total marks out of the 100 marks allotted for the paper. However, such questions are only optional and not compulsory to attempt.

5. Syllabus:

The syllabus for the above selection is enclosed as Annexure to this notification for notifying to volunteering staff.

6. Supplementary examination:

The employees may please note that no supplementary examination will be held.

7. Absorption:

On successful completion of their training, they will be considered for absorption as Junior Engineer(Works) in Level-6 of RSRP Rules in the Civil Engineering department, subject to availability of vacancies as per the panel.

8. Pay, Status & Privileges, etc:

During the period of training they will be entitled to the pay, privilege and status as applicable to their cadre posts which they held immediately, prior to their posting as intermediate Apprentice.

9. How to apply:

Technicians of Civil Engineering department who satisfy the above requirements may submit their application only ONLINE through LAN in the prescribed proforma to reach this Office latest by 16.09.2022.

The Controlling Officer/s are requested to forward all the applications submitted online of all volunteering staff in one bunch, so as to reach Personnel department, immediately after the closing date. It may also be ensured that the candidates do not submit the Online application in Personnel department without being forwarded by their respective Controlling officers.

This may please be given wide publicity amongst the eligible staff of your department and arrangements may please be made to notify the eligible staff working under your control who are on long leave, training, out-station duty, placed on sick list, etc., regarding the above selection. The responsibility of sending intimation to their personal addresses rests with the Controlling Officer/s.
